## PHI LI PPI NE VI SA REQUI REMENTS FOR TEMPORARY VI SI TORS FOR BUSI NESS AND/ OR TOURI SM

- 1. Accomplish F.A. Form No. 2-A (All applications submitted by mail or courier service and through travel agencies or representatives must be duly notarized).
- 2. Submit passport, which should be valid for at least six (6) months beyond the period of stay.
- 3. Attach one (1) 2" x 2" size photo taken within the past six (6) months
- 4. Submit proof of financial capacity to travel:

Tourist:

- A. Round-trip airline/cruise ticket;
- B. Certification from the travel agency that the applicant will be in possession of round-trip airline/cruise tickets;
- C. Copy of checking or savings account.

Business: Letter from company/office requesting the issuance of visa and also stating the nature and duration of trip.

- 5. If applying by mail, please enclose a self-addressed, stamped envelope to ensure the return of the passport (preferably those with tracking numbers)
- 6. Nationals of countries that have diplomatic relations with the Philippines are generally allowed entry into the country without visas for a maximum stay of 21 days or less, provided the nature of the trip is for tourism/vacation. There are, however, exceptions. The maximum length of stay, which is extendible with immigration authorities in the Philippines, is <u>59 days</u>. Please check with the Embassy for further information.
- 7. Schedule of fees:

Α.	Single entry valid for three (3) months	US \$ 30.00
В.	Multiple entry valid for six (6) months	US \$ 60.00
C.	Multiple entry valid for twelve (12) months	US \$ 90.00

Those applying for visas by mail should include:

- The corresponding fee in the form of a money order made payable to the Embassy of the Philippines and;
- A self-addressed stamped envelope with sufficient U.S. postage stamps duly certified or any other reliable form of mail or courier service to ensure the return of the passport (services that use tracking numbers are preferred).
