Amended Protocol II was ratified by Latvia on August 22, 2002 and came into force on February 22, 2003.

Information to the civilian population

The Republic of Latvia has no land mine contaminated areas. WWII UXOs detected by civilians are reported to local police authorities and National Armed Forces. Institutions that are involved in assuring security to the civilians are National Armed Forces and local police forces.
