**Information to the armed forces**

NATIONAL ARMED FORCES provides basic training in mine clearing and mine laying to enable the individual soldier to survive during the most common situations of land mine warfare. Officer and NCO education includes legal aspect of Amended Protocol II

Amended Protocol II was ratified by Latvia on August 22, 2002 and came into force on February 22, 2003.

**Information to the civilian population**

The Republic of Latvia has no land mine contaminated areas. WWII UXOs detected by civilians are reported to local police authorities and National Armed Forces. Institutions that are involved in assuring security to the civilians are National Armed Forces and local police forces.

**International technical information exchange**

LNAF has technical information exchange with the Armed forces of the Kingdom of Norway concerning EOD and not mine clearance.

LNAF has applied for Swedish EOD IS. Currently EOD IS Database is issued to LNAF for evaluation. The decision making process about joining Swedish EOD IS “membership” will be taken in 2007.

LNAF and the Armed forces of the Kingdom of Norway had bilateral project concerning the establishment of EOD school in Latvia. Project has been successfully completed. The co-operation continues in area of IEDD education.
