JCCC-1 Student Suspensions

REASONS FOR SUSPENSION:

Any principal, principal-teacher or assistant principal (herein called principal) may suspend any student from attendance at school or any school-related activity on or off campus (out-of-school suspension) or from attendance at a specific class or classes, or from riding a school bus, without suspending such student from attendance at school (in-school suspension), for good and sufficient reasons including, but not limited to:

- S17 Possession, use or distribution of illegal drugs
- S18 Possession of handgun
- S19 Possession of rifle or shotgun
- S20 Possession of explosive, incendiary device
- S21 Non-lethal firearm
- S22 Possession of weapon other than firearm
- S23 Possession, use or distribution of alcohol
- S24 Violation of school rules
- S25 Theft of property
- S26 Vandalism/damage of property
- S27 Bomb threat
- S28 Other type of threat
- S29 Bullying
- S30 Fighting
- S31 Sexual harassment
- S32 Assault of teacher or staff
- S33 Assault of student
- S34 Sexual assault
- S35 Aggravated assault of teacher or staff
- S36 Aggravated assault of student
- S37 Attempted homicide
- S38 Homicide
- S55 Tobacco violation
