

Landlord Rental Increase Request 2014

A request for rent increase must comply with <u>all</u> of the following requirements before the Indianapolis Housing Agency can approve your request.

- No rent increases can occur during the first 12 months of a new contract.
- Only one request per unit will be processed by this agency during any 12 month period.
- This form must be submitted no less than 60 days **prior** to the contract anniversary date.
- The amount of your request <u>cannot</u> exceed the rents for comparable unassisted units in the same neighborhood of your unit. Ref: 24 CFR 982.507(4)

Note to Landlord: A rent reasonableness test will be conducted. If the results of this test indicate that your current contract rent should be reduced, IHA HCVP is <u>required</u> to reduce the rent accordingly.

- For multi-family apartment building or complex having 3 or more units under the Building Rent Program, you must submit your current rent schedule.
- The <u>tenant must sign</u> this form, verifying they will sign the amended lease for the rent you seek *Note to Tenant: Your monthly portion may increase by some or the entire approved rent increase amount.*
- If the increase is approved, you will be sent a rental change notice.
