Central Park Bridge Design Contest

II.1.2) SHORT DESCRIPTION

London 2012 Olympic Games and Paralympic Games – Structures, Bridges and Highways (Contract Number: INF4.7010.000.P-5225)

The Olympic Park bridges will form an important part of the infrastructure and the operation of the Park both during the Games and into the Legacy of the Games. The ODA wishes to procure the design of one of the Olympic Park footbridges, through a Design Contest.

The bridge (currently numbered F06) is located on the central pedestrian concourse running North to South through the Olympic Park and is in close proximity of the Olympic Stadium.

The ODA is committed to the delivery of design quality and is seeking submissions from Applicants that can demonstrate a high level of creativity and design quality. Submissions from both established and emerging design practices are encouraged. The ODA believes that the Design Team will require a strong leader supported and complemented by other members of the design community.

Design

The bridge will span approximately 26m over Carpenters Lock on the River Lea Waterway and is to be constructed in two permanent separate spans for Legacy. A temporary bridge will be constructed between these two permanent spans to provide the necessary bridge width to accommodate crowd numbers for the Games. It is envisaged that the temporary span will be removed after the Games.

Each of the Legacy spans will be approximately 6.5m wide and the intermediate temporary structure approximately 38m wide to give total clear pedestrian space of 50m. The bridge will be required to carry pedestrians and cyclists and the permanent structure shall be designed to adoptable standards.

The design of the bridge must be in keeping with the overall design language established for the Park. The location requires an appropriately strong design statement that creates a centre-piece, while reflecting the identity and language of the surrounding Park. Meandering strands and bifurcating paths and waterways are major features of the existing Lea Valley in its multiple courses of waterways and ecological corridors. The design language across the park picks up on this network defining scales and materials, for park paths, concourse layouts, topography and key landforms. Pre-qualified Applicants will be briefed on the development of the adjacent Park and bridges before the Invitation to Tender (ITT) period commences.

The tenderers will be invited to develop design proposals for the contest showing the permanent and temporary bridges and the immediate surrounding landscape.

Scope of Design Team Services

It is envisaged that the winner of the competition will be appointed to deliver the following scope of services:

- 1.Develop their concept design proposals through to detailed design.
- 2. Support the design approval process with the ODA and Stakeholders
- 3. Assist in evaluating tenders from constructors for the Works
- 4. Review contractors design proposals
- 5. Site supervision

the design will have to be managed to meet strict cost requirements, and an additional scope item is a detailed cost estimate to support the concept and detailed designs

Prequalification Stage

The current intention of the prequalification exercise is to identify five Bidders for invitation to participate in the Design Contest. It is envisaged that the prequalification will be based on the Bidders response to the PQQ document with the five Bidders with the highest scores being selected to progress to the Design Contest stage.

The criteria that will be used to rank candidates are as follows:

- 1) Financial Profile (15%)
- 2) Governance and Compliance (15%)
- 3) Capacity, Capability and Design Quality on previous projects (70%)

The Tender will be single stage incorporating a Design Contest.
The Invitation to Tender (ITT) document will require applicants to submit technical and commercial proposals in response

to the Design Brief and a set of predetermined questions. Tenderers will be required to submit their design proposals in a set format. The ODA will set up a Technical Panel responsible for carrying out a technical review of the ITT submissions.

The results from the technical review will be passed onto the Jury Panel who will be responsible for judging the Tenderers' design proposals and making an independent recommendation on the selection of the preferred Tenderer. The final selection will be made on the basis of the Most Economically Advantageous Tender (MEAT) as defined in the ITT documentation

Respondents should note that the recommendation of the design jury will not be binding; the final decision on the appointment of the successful Design Team will be made by the Olympic Delivery Authority.

The ODA is responsible for ensuring provision of venues, infrastructure and services for the London 2012 Olympic Games and Paralympic Games (The Games) and the subsequent transition to legacy uses.

The ODA was established by the London Olympic Games and Paralympic Games Act 2006, as a Statutory Corporation, whose Board members are appointed by the Department for Culture Media and Sport (DCMS) in consultation with the Mayor of London. To this end, the ODA is developing the Olympic Park to provide a focus for the Games and a sustainable legacy that will contribute significantly to the regeneration of the Lower Lea Valley.

It is anticipated that the Bridge constructor will be appointed using a single stage procurement for a traditional construct only contract. However, the ODA may opt to use a two-stage procurement for a design and construct contract, which may include the novation of the appointed Design Team and its sub-consultants. The ODA reserves the right to novate the successful design team to a design and construct contractor.

All tenderers will be required to sign the confidentialy agreement with the ODA before being provided with the Invitation to Tender documents.

The ODA expressly reserves the right:

- (i) not to award any contract as a result of the procurement process commenced by publication of this notice;
- (ii) to make whatever changes it may see fit to the content and structure of the tendering competition;
- (iii) to award a contract or contracts in relation to part only of the requirements covered by this notice; [and in no circumstances will the ODA be liable for any costs incurred by candidates, notwithstanding the proposed honorarium to each compliant Tenderer.

The ODA will incorporate a minimum 10 calendar day standstill period at the point information on the award of the contract is communicated to tenderers. This period allows unsuccessful tenderers to seek further debriefing from the contracting authority before the contract is entered into. Candidates have two working days from the notification of the award decision to request additional debriefing and that information has to be provided a minimum of three working days before the expiry of the standstill period. Such additional information should be required from the addressee in section I.1.

If an appeal regarding the award of the contract has not been successfully resolved, the Public Contracts Regulations 2006 (SI 2006 No. 5) provide for aggrieved parties who have been harmed or are at risk of harm by a breach of the rules to take action in the High Court (England, Wales and Northern Ireland). Any such action must be brought promptly (generally within three months). Where a contract has not been entered into, the Court may order the setting aside of the award decision or order the authority to amend any document and may award damages. If the contract has been entered into the Court may only award damages. The purpose of the standstill period referred to above is to allow parties to apply to the Courts to set aside the award decision before the contract is entered into.
