Definitions

Renter – The person who rents the trailer from BuckMann Farm, Dave Dobbelmann, and Tara Buckbee.
Owner – BuckMann Farm, Dave Dobbelmann, and Tara Buckbee.

Rental Deposit - A 25% non-refundable deposit is required at time of rental reservation. Payment in full by personal check is due 1 full week prior to the pick-up date or via Bank Check or Cash upon delivery or pickup.

Damage Deposit – A valid credit card on file, or \$500.00 cash or bank check is required.

Optional Delivery and Pick-up charge - \$1.50/mile from Forest Lake, MN town center. Mileage is calculated round trip. Example, a delivery point 10 miles from Forest Lake town center is 20 miles drop-off and 20 miles pick-up.

Renter Responsibilities - Renter agrees that he (she) is responsible for any and all bodily injury or property damage that may occur while trailer is in his (her) possession. Renter agrees to hold the owner absolutely harmless from any responsibility for any claim whatsoever during the time between pickup and drop off of the trailer.

The renter agrees that the trailer being rented is valued at \$8,000.00 (Eight thousand dollars) and agrees to pay the owner up to this amount for any damage to the trailer. Repair costs will be determined solely by owner's choice of a Minnesota based qualified trailer repair company.

The owner is not responsible for any damages or loss whatsoever to the contents of this trailer. Owner is not liable in any case of theft or injury. Renter assumes all liability. This agreement may be terminated at any time at the discretion of the owner. This agreement does not give the renter the right to rent. Any damage which may occur other than normal wear and tear will be paid by the renter. In the event of disagreement between renter and owner as to the nature of damage, the owner's selected trailer repair facility will determine cause (willful or normal wear and tear). The trailer must be returned clean free of debris or trash. This trailer is for hauling horses and horse related gear only. It is not to be used for hauling other cargo, furniture, snowmobiles, Jet Ski's, trike's, ATV's or other cargo or recreational vehicles. This trailer/unit may not be sublet or subleased to anyone at any time.

Mileage – There is no restriction on mileage and no rate/mile associated with renting this trailer. For the purpose of performing scheduled maintenance, however, the renter requests that a mileage be provided at time of application.

By signing this agreement renter hereby releases the owner and/or any owner employed personnel or affiliates from any liability whatsoever to any damage done to any person, property or anything else while delivering, picking up, moving, or any other reason that owner may be upon the renters property, and any other property that the renter directs the owner to enter upon. Renter expressly releases owner from any liability. Renter assumes all liability for any and all damages done on renter's property etc.

Renter hereby agrees to indemnify owner for any claims of damage, injury, etc. Renter shall defend owner against any claims whatsoever.

Miscellaneous Equipment – Certain items of trailer support equipment is provided with each rental to insure proper, safe and enjoyable hauling and use of the trailer. The renter is responsible for the return of this equipment.

Missing or damaged equipment will be replaced at owner’s expense. These items include...

- Stall trailer ties. Qty 2. \$15.00 each.
- Water tank. Qty 1. \$130.00.
- Rear door lock pins. Qty 2. \$5.00 each.
- Door/window keys. Qty 2. \$5.00 each.
- Spare wheel and tire. Qty 1. \$175.00.

Alterations – Trailers are rigged for carrying 2 horses and horse related items only. Alterations / additions / modification of any kind to the trailer or any part thereof are forbidden. Alterations will be considered willful damage and will be returned to original condition at renter’s expense.

Trailer Repairs - All trailers are well maintained and should provide trouble free use during the rental period. In the event of failure or breakage of any trailer component while underway, the renter is responsible for having the trailer repaired if necessary. All repairs should be performed by a qualified trailer repair shop in the area. All such repairs require prior authorization by the owner via telephone. Any and all resulting repair costs, including tailoring/towing to the repair facility are the sole responsibility of the renter unless agreed in advance by the owner.

Additional days – In the event that the renter is not able to return the trailer as scheduled, the renter is required to notify the owner by telephone. An additional fee of “The Daily Rate” will be applied.

If any part of this agreement is found to be invalid it shall not affect any other part of this agreement.
