This course covers an innovative behavior detection and security interviewing system founded on methods initially developed by the Israeli Security Agency, Shen Bet, and focused on identifying both malicious intent and potential weaponry through training and proper operational protocols, to enhance law enforcement organizations' ability to prevent acts of violence. Participants in this training will learn to recognize pre-incident indicators that expose potential perpetrators of terrorist attack, thus enabling the law enforcement agencies to effectively prevent planned attacks of terrorism.

The key components of this course cover the following:

- Aggressors' methods of operation
- Threat indicators recognition for law enforcement
- Security interviewing for law enforcement
- NYPD debrief of the terror attacks in Mumbai, India and Nairobi, Kenya
- Overview of the attack methods, means and tactics, and police/military response to these extraordinary mass-casualty events

Topics include, but are not limited to:

- Nature of a terrorist threat
- Aggressors' methods of operation
- Pre-operational cycle
- Active shooters: characteristics and modus operandi
- Suicide bombers
- Components of a terrorist attack
- History of SIRA
- Law enforcement applications of SIRA
- Suspicion indicators

This course will be taught by: Mr. Michael Rozin, Chief Instructor, Rozin Security Consulting, LLC; and Lieutenant Kevin Yorke, New York Police Department, Intelligence Bureau.

This course qualifies toward Police and Deputy Chief annual training, as mandated in 50 ILCS 705/10.7, and meets the requirement for PTSD training mandated by PA097-1040, and the Illinois Law Enforcement Training and Standards Board.
