The norms fixed for raising of seed nursery, incentives for cultivation of high sugar content varieties and ratoon management for tropical and sub-tropical region be strictly followed, otherwise the difference of cost have to be bom by the respective sugar factory and hence the application may be sent back to concerned sugar factory for its revision.
