1. All entries will be judged in three age-group categories. Years of experience will be taken into account when judging.

2. Job's Daughter contestants submitting entries must be in good standing with JDI as of **August 5, 2014**.

- 4. The Chairman will acknowledge all email registrations by return email. If you wish acknowledgement of a mailed registration, please include a stamped, self-addressed envelope.
- 5. A contestant may enter only one item per Category. The contestant does not need to be in attendance at Supreme Session to enter. The name of the person responsible for picking up the entry must be clearly stated.
- 6. Each contestant determines in which division and category she wishes her entry to be judged; however, the Arts and Crafts Committee reserves the right to adjust categories.
- 7. Entries must be presented to the Arts and Crafts Committee on Tuesday. August 5th, 2014 between 9 AM and 5 PM. Check the location of the Arts and Crafts competition in the Session program and/or newspaper. No late entries will be accepted unless caused by a travel emergency.
- 8. The entry must be as described on the registration form; substitutions will not be accepted.
- 9. Entry forms must be legible or will not be accepted.

- 10. Contestants are responsible for storing their own packing material. Packing material left in the competition room will be discarded.
- 11. Judging will be done during the evening of Tuesday, August 5th. No viewing of the entries will be allowed before or during judging.
- 12. Judging will be based on the following, as applicable: originality, design, artistry, presentation / layout, degree of difficulty, craftsmanship, neatness, and finishing. Completed judging score sheets will be given to the contestants. The decision of the judges is final.
- 13. The competition room will be open for viewing Wednesday, August 6th from 9 AM to 5 PM. All entries must remain in the competition room during this time.
- 14. Entries must be claimed from the committee on Friday, August 8th between noon and 5 PM unless other arrangements have been made with the Arts and Crafts Committee Chair.
