



# Boat Registrations Registration of a Foreign Pleasure Vessel

45BAA Navigable Waters Regulations 1958

A foreign pleasure vessel is a registrable vessel which is owned by a person who is not a permanent resident of Western Australia (WA) and is temporarily within WA navigable waters. It does not include a registered interstate pleasure vessel. If the vessel remains in WA navigable waters for a period greater than 30 days the vessel must be registered with the Department of Transport as a Foreign Pleasure Vessel.

### What is required

To register a Foreign Pleasure Vessel the Department requires the applicant to provide:

- a recording fee of \$19.60 and the appropriate fee in accordance with the following table for each three (3) month period or part there of for the proposed vessel to be used in navigable waters;
- proof of identity (POI) documents (see below for details); and
- the appropriate fee as per the table below - Where the length of the vessel is;

| Less than 5 metres                        | \$4.00  |
| 5 metres or over but less than 10 metres  | \$7.25  |
| 10 metres or over but less than 20 metres | \$9.50  |
| 20 metres or over but less than 30 metres | \$19.00 |
| 30 metres or over but less than 40 metres | \$38.00 |
| 40 metres or over                         | \$76.00 |

### Proof of Identity (POI)

When you submit this form you must provide POI documents to the Department's Boat Registrations Office before this form can be accepted.

#### **Applicants must submit one full POI (no other proof required) documents, including:**

- a current photographic driver's licence;
- a current passport.

#### **Secondary POI**

If no full POI document is available, applicants will require two (2) secondary forms of identification including:

- a current non-photographic driver's licence;
- a foreign passport or foreign document of identity that is current or has expired within the last two (2) years;
- a full birth certificate, or an extract of birth certificate (must be certified copy from issuing body);
- a current credit card/account card, passbook or account statement not more than twelve (12) months old;

#### **Company POI**

If the vessel is to be registered in a company name the following documents are also required:

- a Certificate of Incorporation of the company (or a certified copy).

This application form must be signed by a Director or Company Secretary, in addition POI for the nominated contact person is required.

### Privacy Statement

The information submitted within this form may be used for the purpose of compliance with and enforcement of the *WA Marine Act 1982*. It may also be disclosed to any person who, in the Director General of the Department of Transport's view, has legitimate interest in obtaining information from the Department.
