

Dear Class of 2014 Parents and Students,

As parents of high school students, you are acutely aware of the high cost of the activities that all Senior classes have: senior rings, graduation invitations, senior pictures, cap and gown purchases, yearbooks, just to name a few. Lakeview Centennial High School Class of 2014 Booster Club would like to make our senior activities available and affordable to every student by establishing a Senior Contract that provides a payment installment plan for such activities.

A contract will be established for each student in the class of 2014 that will allow for most of the senior activities to be paid for in installments. If you take advantage of our lowest payment option, (see next page) all planned activities will be paid for in advance prior to their senior year. This plan will be beneficial to students and parents due to the cost savings (refer to table on the next page).

Without this contract, parents and students will have to pay more money for the planned senior activities or will be required to participate in more fund raising activities over the next three years.

The following events will be included in the contract:

- **Senior Prom** - The biggest and most elegant of all senior activities, the price includes one person admission to the dance, casino party, buffet, and door prizes.
- **Senior Day** - A casual gathering, on a school day, where LCHS Seniors enjoy lunch and time together at an off-campus location.
- **Senior Luncheon** - A gathering of family and friends to reflect and celebrate this special time in your student's life. This event would be held in May of 2014 and will include lunch and video presentation. Additional tickets would need to be purchased for family members, etc.
- **Senior Video** - A photographic collection of all memories set to music. We will be requesting a baby picture and a current picture of each senior and any other special photos you would like to include. Group photos from elementary, middle, and high school are great. This request will be in the 2013 school year.
- **Senior T-shirt** - This is an LCHS tradition as the banner in the front of the school is changed at the end of the junior year, each student will receive a special shirt to wear to the sign change ceremony.
- **Senior Gift** - It is a LCHS tradition that the Senior Class leaves a gift to the school when they graduate.

Details of the activities will be finalized at a later date based on the number of participating students at the end of the class of 2014 junior year. All events are determined and planned by the Class of 2014 students, Sponsors, Class Officers, and Booster Club.

If you have not attended one of the booster club meetings, we encourage you to do so.
