

#### INDEPENDENT ACCOUNTANTS' REPORT ON APPLYING AGREED-UPON PROCEDURES

Secretary of State of Ohio Democratic Executive Committee 130 West Fancy Street Blanchester, Ohio 45107

We have performed the procedures enumerated below, to which the Republican Executive Committee, Clinton County, Ohio (the Committee), agreed, solely to assist the Committee in evaluating its compliance with certain requirements included in Ohio Rev. Code Sections 3517.1012, 3517.13(X)(1), 2(b), (3)(a), and (4), 3517.17, and 3517.18, for the year ended December 31, 2009. The Committee is responsible for complying with these requirements. We followed the American Institute of Certified Public Accountants' attestation standards for agreed-upon procedures engagements and applicable attestation engagement standards included in the Comptroller General of the United States' *Government Auditing Standards*. The sufficiency of the procedures is solely the responsibility of the Committee. Consequently, we make no representation regarding the sufficiency of the procedures described below either for the purpose for which this report has been requested or for any other purpose.

#### **Cash Receipts**

- 1. We inquired of the Committee whether they deposited all gifts from corporations, labor organizations and all gifts restricted to operations into the same fund into which they deposit amounts received from the State Tax Commissioner. Management informed us they received no such gifts.
- 2. We footed each *Statement of Political Party Restricted Fund Deposits* Ohio Rev. Code Section 3517.17 requires (Deposit Form 31-CC), filed for 2009. We noted no computational errors. The Committee substituted form 31-E in place of form 31-CC.
- 3. We compared bank deposits reflected in 2009 restricted fund bank statements to total deposits recorded in Forms 31-E filed for 2009. The bank deposit amounts matched what was recorded in the Form.
- 4. We scanned the Committee's 2009 bank statements and noted they reflected three of the four quarterly payments that should have been received from the State Tax Commissioner pursuant to Ohio Rev. Code 3517.17(A). Form 31-E properly reported the three payments. We instructed the Treasurer to request reissuance of the quarterly payment not received (totaling \$3.04).
- 5. We scanned other recorded 2009 receipts for evidence that a corporation or labor organization may have exceeded the \$10,000 annual gift limit Ohio Rev. Code 3517.13(X)(3)(a) imposes. We found no evidence that any corporation or labor organization exceeded this limit.

#### **Cash Reconciliation**

1. We recomputed the mathematical accuracy of the December 31, 2009 reconciliation for the bank account used for receipts and disbursements restricted pursuant to Ohio Rev. Code Section 3517.1012(A). We found no computational errors.

- 2. We agreed the bank balance on the reconciliation to the bank statement balance as of December 31, 2009. The balances agreed.
- 3. We agreed reconciling items appearing on the reconciliation to canceled checks, deposit slips. We determined that there were no reconciling items as of December 31, 2009.

Cash Disbursements – there were no cash disbursements made by the Committee during 2009.

We were not engaged to, and did not examine each Statement of Political Party Restricted Fund Deposits and Statement of Political Party Restricted Fund Disbursements filed for 2009, the objective of which would have been to opine on compliance. Accordingly, we do not express an opinion. Had we performed additional procedures, other matters might have come to our attention that we would have reported to you.
