Behavior Contract – Montreal 2010

The behavior of one irresponsible child on a field trip could put the safety of all individuals attending the activity in jeopardy. We believe that only those students demonstrating responsible behavior should participate in off-campus activities. We are unwilling to take the chance of including a child who demonstrates the inability to take responsibility for his/her behavior on field trips. As a result, we have set expectations for student behavior in order to be allowed to attend a field trip and while on the field trip.

Students participating in field trip activities must abide by the following rules and regulations:

1. All rules, regulations and policies governing student behavior at LILA are to be followed during trip.
2. Students are to cooperate fully with and follow the instructions of all chaperones and other supervisory personnel. Repeated refusal to follow requests/directions of trip supervisors/chaperones or violation of school rules, regulations or policies will result in parents being notified and student disciplined upon return to school. Behavioral problems may result in the misbehaving student being sent home at the expense of the parents.
3. No possession or consumption of alcohol, illegal controlled drugs, or smoking is allowed at any time during the trip, including transportation. Any violation of the drugs, tobacco or alcohol policy will result in parents being notified and the student may be sent home at the parents' expense. If illegal substances are found, the police will be notified and prosecution may also result.
4. No weapons, firearms, or dangerous instruments (pocket knives, for example) may be brought or used during the trip. If the student violates this policy the parents will be contacted and the student may be sent home at parents' expense. Expulsion proceedings are required in such cases.
5. The LILA Board, its employees, agents or representatives are not responsible for any accident, injuries, damages or other losses to the person or property of participants during a school trip.
