Community Service Restitution Program & School Suspension Program

The School Suspension Program (SSP) has been a program at the Center for Community Justice since the fall of 2004. The need to give youth a meaningful experience during the time that they are suspended or expelled from school became the motivation for starting the program. At that time we decided to utilize Community Service Restitution as an alternative for youth, rather than doing nothing during the time that they are suspended or expelled from school. We worked with the probation department and the juvenile magistrate, to determine how this project could benefit juveniles who are in the Elkhart County justice system. As a result of these discussions the SSP program was begun. It was set up so that the probation officer can require them to perform six hours of community service for every day they are suspended or expelled from school. The SSP program has had 47 students referred to CCJ thus far this year. We have also increased our client referral sources to include Concord High School, Concord Intermediate School and Baugo Elementary School. We have expanded our worksites to include Voice Ministries, Breath of Life Church as well as Susanna's Kitchen. This work has been a positive influence in the Elkhart community by providing valuable assistance to the worksites but most importantly in giving youth an opportunity to give something back to the community. We would be pleased to speak with you about how you can be involved making sure that this program can continue to grow.

Victim Offender Reconciliation Program

Between July 1, 2010 through December 31, 2010

- •146 restitution contracts have been signed.
- •81% of restitution contracts signed through VORP have been closed successfully.
- •VORP staff facilitated \$60,219 in restitution to victims.
- •VORP facilitated 38 face-to-face meetings between victims and offenders.
- •91% of offenders reported that after their participation, they have a better understanding of how the victim was affected by the crime.

•90% of offenders reported that VORP provided them the opportunity to make things right.

Some Offenders who participated with VORP have said:

"Thank you for your understanding in regards to this case. Meeting eye-to-eye with the victim was of great beneficial value to me, and I know that I've become a more responsible person after this. Again, thank you for all you've done." (18yo offender)

"I'm just glad that I have a chance to do the right thing now. I'm wanting to learn from my mistakes so I can have something to teach my daughter in the future." (23yo offender)

Some Victims who have participated with VORP have said:

"This is the first crime committed to us as a small business that will actually (hopefully) result in full financial restitution. We have been in business for 37 years and had numerous small thefts. If the criminal was caught, the crime was usually plea bargained away to he was sentenced for a bigger crime [and not held responsible for the theft]. We are very happy for your VORP and hope to see restitution in full in the future." (59yo victim)

"This program seems to be very effective. I was an officer who pursued the offender, so I don't really see myself as a victim, but even in my case, it helped to have the offender apologize to me and explain why he did what he did. If I was a true victim of a crime, I think it would have helped enormously and hopefully it would give the victim a face and personality that would hopefully prevent the offender from committing the crime again." (27 v/o police officer)

"Restitution was important for offender's accountability. It assists us in paying for repairs that are not budgeted."

Family Mediation Program

Life is often stressful and challenging, placing strain on families. The strain may cause conflict in family relationships, possibly breaking the family apart. This is often a crisis for the family members, including children, moms, dads, siblings and grandparents. **Mediation** provides an opportunity for parents or guardians to openly address concerns and issues with one another in the presence of a professional neutral party, a mediator. The participants have the opportunity to construct an agreement that is livable, realistic and reflective of their mutual desire to protect and nurture their children. News From Notre Dame

On January 28, 2011, we had the opportunity to present about ways restorative justice can work within the criminal justice system to Notre Dame Law students taking a class on Criminal Justice Policy-Restorative Justice.
