*Age as of April 1, 2014.*

The 2014 Season begins April 1, 2014 and goes through December 31, 2014.

## **How to Enter:**

**Step One: Check to see where a preliminary pageant is being held near your area.**

**Step Two: Apply directly to Sterling Miss Productions by printing out the application and other paperwork and returning it to the office by the due date.** Just download the application via our website or request an application via email.

**Step Three: Application Accepted!** Once your application has been accepted, you will receive an Official Acceptance Letter via email and a complete guide to preparing for your preliminary pageant.

**Step Four: Prepare for you competition.** You will compete in Formal Wear and Casual Wear only at the preliminary level of competition. Optional contests are also available.

At the state level, you will compete in formal wear and interview. You may also wish to compete in our optional contests like Actress, Casual Wear, Photogenic, Spokes Model and Talent. Our Mini-Optionals offer another chance to win, as you compete in: Best Formal Wear, Best Interview, Best Personality, Prettiest Eyes, Prettiest Hair and Prettiest Smile. Cash prizes and trophies will be offered for each age category and optional category.

## **Preliminary Pageant Expenses**

**Registration Fee: \$99.00**

**Scholarship Fee: \$25.00-** Each preliminary contestant is required to raise or donate \$25 to the Sterling Miss Pageant Scholarship Fund. This amount is paid at check-in in CASH. The amount of the scholarship per age category is determined by the number of contestants. A portion of the funds collected will go towards the State Pageant Scholarship Fund which will be presented in the pageant in January 2015.

Preliminary Competition attire: Formal Gown

A walking diagram for formal walk will be emailed to you in advance of the pageant for practice. Pageant staff will be available to assist you with any questions you might have prior to the pageant.

There is no swimsuit competition.

There is a no make-up rule for girls 9 and under. Contestants age 10 – 12 are permitted to wear light natural make-up. For ages 13 and up, normal make up is allowed – just remember to let your natural beauty shine through! Spray tans are allowed. No flippers (fake teeth). No hair pieces, though hair extensions are allowed.

No PRO AM MODELING (dance moves incorporated into your routine).

Preliminary participants are *not required* to sell ads for the program book.
