



Music Performance at IES Abroad Vienna



The Music Performance Application is only required if you wish to participate in the Individual Performance Studies (MS391) and/ or in the Music Performance Workshop (MS 390). General description of IES Abroad Vienna music program options are provided below. More detailed information can be found in the country-specific IES Abroad Vienna catalog or the IES Abroad website at www.IESabroad.org.

All students of the Music Program at IES Abroad Vienna can take advantage of the following privileges, regardless of the courses they take:

- Private lessons with a highly-qualified local instructor
- Lesson documentation (of the number of lessons taken and an end-of-semester evaluation by the private instructor)
- Free access to practice facilities (operated and maintained by IES Abroad)
- Free use of our concert hall for individual student recitals
- Attendance at rehearsals of professional performance organizations (like the Vienna Philharmonic)
- Assistance in arranging for instrumental rentals and/or studio time (harp, percussion, etc.)

Vienna Fall and Spring Music Program

For those interested in performance for credit, we offer two courses:

- **Individual Performance Studies** (MS391; 1, 2, or 3 credits)
- **Music Performance Workshop** (MS390; 3 credits; admission by audition only).

A student may register for either or both courses (for instance, Workshop for ensemble credit and Performance Studies for lesson credits). Both courses require submission of the *Music Performance Application Form* and the *Music Instructor Form*. Note that a student may be eligible to receive lesson credit from their home school by appending the lesson documentation forms to their transcript (instead of taking MS391). These options should be discussed with the home music department before participating. Fall and Spring student will complete the *Music Performance Application Form* in their **My IESabroad account**. Further information regarding the instructor portion can be found further down on this document.

Individual Performance Studies (MS391)

Individual Performance Studies (MS391) is dedicated to a hands-on approach to the performance of music under the supervision of professional Viennese musicians. The number of credits awarded is determined by the number of contact hours with the personal instructor, number of hours of private practice, and the optional preparation of a private solo recital. Important: All participants in MS391 must play at a hearing before the music faculty so that they can assign you an appropriate personal instructor. There are no required pieces for you to learn and you will be allowed to take this course given a minimum level of performance; simply choose (at least two) works that represent your abilities as a performer. If you audition for the Music Performance Workshop, you do not have to participate in an extra hearing for MS391.

Music Performance Workshop (MS390)

Music Performance Workshop (MS390) is designed to offer vocalists and instrumentalists the opportunity to expand repertoire and enhance performance skills in the context of group performance. The pieces studied are chosen on the basis of enrollment in the course (i.e., constellation of instrument and voice types) and – depending on the possibilities – reflect a range of styles from lied performance to short opera scenes, from instrumental duos to arrangements for chamber orchestra. Sessions consist of a combination of coaching and discussion of aspects of the works in relation to history, analysis, and the challenges of performance. Admission into the course is predicated on a successful audition. Vienna Summer Music Program

The summer music program at IES Abroad Vienna is designed for music and performance majors (as well as accomplished instrumentalists and vocalists) and consists of IES Abroad courses in Music History, Performance Studies, and German Language. Vienna Summer student will need to complete a paper application of the Music Performance Application. The summer Music Performance Workshop is an opportunity to expand repertoire and enhance performance skills. In addition, students receive individual technical training (up to six hours of private instruction is included in the program fee) and may participate in master classes. The Workshop requires advance application and a YouTube link of selections compliant with the Performance Workshop Audition Repertoire List. The recording must be of unedited live performance, including the accompaniment part if the score calls for it. The Music Performance Form, Instructor Portion and YouTube link(s) must be sent IES Abroad by the application deadline. Performance Application Deadlines

Fall and Spring Vienna Students

The completed *Music Performance Form* is due in your **MyIESabroad account** and participation in the Music Performance Workshop requires an onsite audition. Please make sure to consult the repertoire list in your **MyIESabroad account** after an admission decision has been made. You will receive an official due date on the *Music Performance Form* and on the *Instructor Form* after you are accepted.

Vienna Summer Music Program Students

The completed Music Workshop Application and YouTube link of audition pieces must be submitted to the IES Abroad Chicago with your IES Abroad application by the application deadline.

In order for your application to Individual Performance Studies (MS 391) and/ or the Music Performance Workshop (MS 390), you are required to have authorization and the *Instructor Form* filled out by your current or most recent music instructor. It is your responsibility to ensure you will receive any necessary credit at your home institution for music performance.
