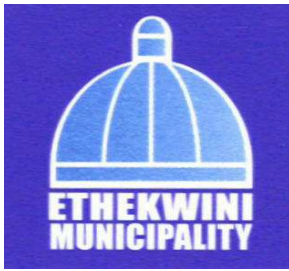

8. Do not add products to your stand without prior consent of management.
9. All food vendors that are cooking on the premises must have a visible fire extinguisher on display.
12. All food vendors must have the hawking license before trading.

All products sold at the market must be manufactured in South Africa.

The market will be on the last Sunday of every month unless decided otherwise by Business Support, Tourism and Markets Unit management.

When returning the form, kindly attach the product photos, failure to attach photos will result in disqualification.

Selected businesses will be required to pay a booking fee of R 100.00 (subject to change)
