WHEREAS, on February 18, 2011, BA Park Group, LLC made a request for an Open Development Area to the Colonie Town Board; and

WHEREAS, the Town Board referred this matter to the Planning Board for advice and recommendation via Town Board Resolution No. 250 for 2011; and

WHEREAS, Town Law § 280-a (4) provides that the Town Board may establish an Open Development Area within the Town, wherein permits may be issued for the erection of structures to which access may be given by right of way or easement, upon such conditions and subject to such limitations as may be prescribed by general or special rule of the Planning Board; and

WHEREAS, the BA Park Group, LLC owns a certain parcel of land known as 29 British American Boulevard (SBL#18-1-49.44) which contains three separate addresses known as 25, 27 and 29 British American Boulevard, each address receiving a separate tax bill; and

WHEREAS, the addresses known as 29 and 25 British American Boulevard have already been developed in conformance with approved site plans (Approvals: 02-099 and 06-074 respectively); and

WHEREAS, the address known as 27 British American Boulevard is an approved building site (Approval: 06-074); and

WHEREAS, the applicant has also filed an application for a minor subdivision in order to create three legally separate parcels with primary access for ingress and egress via British American Boulevard to be provided by a recorded and legally binding reciprocal easement agreement, and with secondary emergency ingress/egress pre-existing; and

WHEREAS, the easement for primary ingress and egress – a 24-foot wide paved roadway – provides adequate safe access to the three addresses for emergency vehicles and service apparatus; and

NOW, THEREFORE, BE IT RESOLVED THAT

Upon consideration of the above statements and findings, the Planning Board recommends that the request for an Open Development Area, pursuant to Town Law § 280-a (4) for 25, 27, and 29 British American Boulevard, be approved in all respects, subject to the following conditions:

- That said easement must also include a provision making each address (and/or future parcel) parcel jointly and severally liable for maintenance of the roadway.
- 4. That the easement agreement be made part of the legal description in the deed to be recorded for each parcel.
- 5. That the Open Development Area designation and access by easement, including the revised deed description relative to the terms of the easement, with the amended language as set forth herein, must be included on the final subdivision map.
- 6. That any future changes to the recommended Open Development Area, including but not limited to addition, demolition, structural or site changes, subdivision, and change in use or tenant, must comply with all applicable Town of Colonie processes and approvals.
- 7. That a hold harmless and indemnity agreement must be entered into with the Town of Colonie, protecting the Town from liability in connection with the access to the subject property.
- That satisfactory proof must be demonstrated to the Town that the property owner has a legal right of way or easement to the access the subject property.
