Project, Balimela At/PO: Balimela Dist: Malkangiri, Orissa, Pin No.764051 from intending vehicle owners/Travel Agencies for hiring of following Nos. of commercially registered new light vehicles on monthly hire basis for a period of 02 years to be engaged at BHEP, Balimela for 24 hours duty as per details mentioned hereunder with the following terms & conditions:

- a) The contract shall be valid only for a period of *twenty-four* months from the date of deployment of the vehicle. It can however be further extended for another two years, one year at a time after successful completion of each contract period and performance certificate from the concerned Manager (El). The department reserves the right to terminate the contract at any time during the contract period without assigning any reason thereof.
- b) The month and year of manufacture of the vehicle must be on or after **01.12.2012**.
- c) The vehicle should have minimum mileage of 13 Kms/Litre of Diesel. The fuel is to be supplied by OHPC authority.
- d) 1 (one) Ltr. of Mobil will be provided by OHPC for each 500 Kms run of vehicle.

- 1) <u>RECEI PT OF TENDER</u>: The Senior General Manager (Electrical), Balimela Hydro Electric Project, Balimela-764051, Dist. Malkangiri (Odisha) shall receive the tenders, in duplicate, for "01 No. of Mahindra Bolero –XL or DLX or higher version (diesel) for Manager (El.) Generation Division, BHEP, Balimela.." on or before 08.01.2013 till 04.00 P.M. The date of manufacturing/Registration of vehicle should be as per tender notice.
 - 2) <u>OPENING OF TENDER</u>: The tenders shall be opened at **04.30 P.M**. on **08.01.2013** in the presence of the Tenderers or their authorized representatives who may be present.
 - SUBMISSION OF TENDER: Tenders shall be submitted, in duplicate, together with other documents in sealed envelope superscribed on the envelope "Tender Call Notice Number, the name of the work and the date of opening of the tender on the body of the sealed envelope". Conditional & telegraphic tender, tender incomplete in any shape and not accompanied with requisite amount of E.M.D/security deposit (if required as mentioned below) is liable for rejection.
 - 4) RIGHT AND AUTHORITY OF REJECTION: Tenders received after due date and time will be summarily be rejected. The Senior General Manager (Electrical), Balimela Hydro Electric Project, Balimela, reserves the right to reject any or all the tenders without assigning any reason thereof.
 - 5) <u>VALI DITY OF OFFER</u>: The offer should be firm and valid for a period of at least 120 days from the date of opening the tender.
 - 6) EARNEST MONEY DEPOSIT: Tenders should be accompanied with Earnest money deposit of 1 % (one percent) of tendered value for 02 (Two) years only for vehicle in the shape of Bank Draft/Bankers' Cheque, payable at State Bank of India, Orkel (Code-4853), AT/Post: Balimela-764051, Dist. The E.M.D. of successful tenderer will be forfeited, if the tenderer fails to execute the order.
 - 7) <u>DOCUMENTS:-</u> The following documents will be required to be produced before the execution of the agreement.
 - (a) Make, Type and year of manufacturer of the vehicle.
 - (b) Attested copy of the R.C.Book.
 - (c) Attested copy of the contract-carriage license.
 - (d) Attested copy of the first party Insurance.
 - (e) Name of the Driver and attested copy of his valid driving license.
 - (a) Passenger carrying capacity of the vehicle.
 - (g) All Orissa Road Permit.
 - (h) Relevant documents of loan, if availed, for purchase of the vehicle.
 - (i) Upto-date Service Tax Registration Certificate & I.T.PAN.
 - (j) Registration certificate and Travel Agency certificate.
 - The vehicle against which tender submitted will only be accepted for taking on hire. Subsequent change of vehicle will not be allowed. But in case of any repair of the vehicle, a proper substitute vehicle should be provided for such repair period only.
 - 9) The Tenderers shall sign on all pages of the tender document as a token of acceptance of all Terms and Conditions thereof and submit his quotation.
 - All correspondences relating to the tender shall be made with the Senior General Manager (EI), Balimela Hydro Electric Project, Balimela in the following address.

B) GENERAL TERMS AND CONDITIONS:

- 1) The vehicle will be utilized by Manager (El) Generation Division, BHEP, Balimela, also the contract agreement will be executed with the Manager (El) Generation Division, BHEP, Balimela.
 - 2) The contract shall be valid for a period of 02 (Two) years from the date of execution of the agreement. It can however be further extended for another two years, one year at a time after successful completion of each contract period and performance certificate from the concerned Manager (El). The department reserves the right to terminate the contract at any time during the contract period without assigning any reason thereof.
- Only fuel and Engine Oil required as per actual consumption for running of the vehicle shall be supplied by the department on an average run of not less than 13 Kms per liter of Diesel and 500 Kms per liter of Engine Oil. In the event of Non-supply of these items by the Department, the contractor shall supply the same and shall get reimbursed alongwith his monthly hire Bill against production of cash voucher for the same. Other items like change of Engine Oil replacement of spare parts and all maintenance charges etc will be borne by the owner of the vehicle. The contractor can not stop the duty with a plea that, the department did not supplied the fuel or the lubricants in time. The firm have to arrange the required fuel and lubricants from their sources and can reimburse alongwith the monthly hire bill. If any such incidence will come to the knowledge of the undersigned, the agreement with the firm will be cancelled and the security deposite so deposited will be forfeited.
- 4) The date of manufacturing of vehicle should be as per tender notice. It should be kept in good running condition, so as to provide safe and trouble-free journey and to avoid any breakdown enroute. The vehicle is supposed to run on all conditions of roads including village, Kachha Road, Ghat Section road from Balimela Power House to Valve House with Head Quarter at Balimela.
- 5) Any minor maintenance/periodical check-up of the vehicle may be taken-up by the supplier only during idle hours without hampering OHPC work.
- 6) In case of any breakdown maintenance work of the supplied vehicle, a suitable substitute vehicle of similar condition with one suitable driver is to be provided by the owner of the vehicle.
- Payment of all taxes, insurance in respect of the vehicle should be kept up to date. The hired vehicle should have 1st. Party Insurance. If any accident occurs at the time of conveyance, the owner of the vehicle should be liable to pay all the compensation as fixed by the court of law to the persons affected in that accident, OHPC should not have any liability in this regard. The firm have to indentify the same to OHPC Balimela.
- 8) OHPC Limited shall in no way be held responsible for any damage/breakage/theft caused to the hired vehicle on any account during the course of its hire.
- 9) The Driver of the vehicle should be of good health, good conduct, reliable, sober in nature and free from bad habits of any type of intoxication. He must possess valid driving license and an aptitude for safe and steady drive. He must possess all the relevant papers of the vehicle for producing the same before law enforcing authority as and when required. If any complaint will be received against the driver, the driver should be replaced within 24 hours with a new one.
- Driver's salary and his lodging/boarding expenses during the tour from the Head Quarters and while stationed at Head Quarters are to be borne by the Contractor. However, for outstation tour involving night halt an amount of Rs. 180/- towards drivers lodging and boarding charges for each night halt will be given by the Department.

Lodging - Rs. 100.00 D.A. - Rs. 80.00

Total/Night halt. - Rs. 180.00 (Rupees One hundred Eighty) only.

For it the Driver has to submit the documents signed by the user.

- The hire charge bill in duplicate along with the original log book of the vehicle duly entered and signed by the Driver and the Officer(s) using the vehicle should be submitted to the Senior General Manager (El), Balimela Hydro Electric Project, Balimela, through the Manager (El), in charge of vehicle at the end of each month for release of payment to the Contractor in shape of cheque or Bank Draft after deducting Income Tax as per rule. In case of demand draft, the commission should be borne by the firm.
- In the event of failure to supply the vehicle on any reason and any day during the contract period and failure to provide the substitute vehicle in lieu of that, a penalty amount of Rs. 1000/- (Rupees One thousand) only + proportionate charge of that day subject to maximum amount equal to one month hire charge shall be imposed on the contractor. If the penalty will be more than the one month hire charge bill of the vehicle, then OHPC reserves the right to terminate the contract and if the contract is terminated because of this, then the security deposit already deposited by the firm will be forfeited. Once the agreement is made by the firm to deploy the vehicle, the firm can not withdraw that vehicle without giving any substituted vehicle during the contract period, unless the security deposit deposited by the firm shall be forfeited and the firm shall be black listed.
- An initial security deposit of 5% of the contract amount will be deposited before the execution of the agreement & 5% of the billed amount will be deducted from bill amount in every month shall be furnished by the successful tenderer with the Manager (EI), Generation Division, Balimela by D.D./Bankers cheque in favour of OHPC Ltd. Payable at SBI, Orkel, Balimela (Code No.4853) towards security deposit, which will be refunded to the tenderer after successful completion of the contract period.
- 14) The successful Tenderer have to supply the vehicle within 30 days of issue of the Work Order, unless the order will be treated as cancelled and his EMD will be forfeited.
- The successful tenderer has to execute an agreement on a Non-Judicial stamped paper of worth Rs. 100/- with the Manager (El) Balimela Generation Division, BHEP, Balimela after receipt of work order and furnishing of security deposit before providing the hire vehicle under the General Terms and conditions stipulated for the purpose.
- The contractor has to furnish a certificate that, he is neither an OHPC staff nor related to any of the OHPC Employees of Balimela Unit.
