IF YOU HAVE MORE THAN ONE DEPENDENT THEN THE PRINCIPAL APPLICANT COMPLETES ITS PACKAGE FIRST. I-485, I-765, I-131, G-325A AND FAX IT TO OUR OFFICE FOR REVIEW; WHEN FAXING THE G-325A ONLY SEND ONE PAGE.ONCE WE REVIEW THE FIRST SET, THE REST OF THE APPLICANTS CAN EASILY FILL THEIR FORMS.

WE WOULD LIKE THAT THE FORMS ARE DONE AT ONCE. SO WHEN COMPLETING THEM IF THERE ARE SOME QUESTIONS THAT YOU DO NOT KNOW HOW TO ANSWER THEM PLEASE EMAIL ME IMMEDIATELY IN THE SUBJECT LINE WRITE. URGENT COMPLETING FORMS HAVE A QUICK QUESTION. YOU CAN ALSO TRY CALLING ME AT THE OFFICE BUT IT'S ALWAYS EASIER CONTACT ME VIA EMAIL.
