2. Applicants may use extra sheets, in case of insufficient space in the columns of the form.
3. Four passport size photographs should be attached with the visa form.
4. Normal visa processing time is 1-2 weeks.
5. Applicants could be asked to appear for interview, if required.
6. Attach bank statement for business visit.
