#### CLIMATE READY SCOTLAND: DRAFT SCOTTISH CLIMATE CHANGE ADAPTATION PROGRAMME CONSULTATION

#### **REPORT BY STRATEGIC DIRECTOR – COMMUNITIES**

#### ABSTRACT

This report proposes a response from Angus Council to the Scottish Government's consultation document: Climate Ready Scotland: Draft Scottish Climate Change Adaptation Programme.

#### 1. RECOMMENDATION(S)

It is recommended that the Committee:

(i) approve this report as Angus Council's response to the Scottish Government.

#### 2. BACKGROUND

- 2.1 The consultation seeks views on a Programme, as required by section 53 of the Climate Change (Scotland) Act 2009, which sets out Scottish Ministers objectives, proposals and policies for addressing the impacts identified by the UK Climate Change Risk Assessment (CCRA) that have been identified as a priority for Scotland over the next five years.
- 2.2 Scotland's climate is changing. Over the last few decades it has become warmer, but also wetter, with an increase in both the amount of rainfall (especially in winter) and the occurrence of heavy downpours. Temperatures between 2003 and 2007 in Scotland were the highest since records began in 1910 and in 2011; rainfall in Scotland was some 35% more than the average for the period between 1961 and 1990.
- 2.3 We have recently experienced extreme weather in Scotland. Examples include the devastating winter storms in December 2012 across areas of eastern and northern Scotland, the very strong winds across much of the UK in December 2011 and January 2012 and the extremely cold winter of 2009/10. - 2.4 Climate projections for the next century indicate that the climate trends observed over the last century will continue and intensify over the coming decades. A rise in temperature of a few degrees would create conditions unlike anything experienced in Scotland today. We may have fluctuating temperatures and more prolonged periods of high rainfall or drought, leading to more extreme weather events, like heat waves or heavy rainfall. This will present a wide range of threats and opportunities to the environment, infrastructure, economy and people in Scotland.

#### 3. CURRENT POSITION

- 3.1 The Scottish Government recognises that much of the change in climate over the next 30 to 40 years is already determined by past and present emissions of greenhouse gases and by the inertia of the climate system some degree of further climate change is inevitable. While we cannot prevent this change, we can be more resilient and manage its consequences.
- 3.2 By planning and preparing for change now, the Scottish Government believe that Scotland will be better placed to take advantage of any opportunities and build resilience to the potential negative consequences that this change is bringing.
- 3.3 The consultation seeks views on a Programme, as required by section 53 of the Climate Change (Scotland) Act 2009, which sets out Scottish Ministers objectives, proposals and policies for addressing the impacts identified by the UK Climate Change Risk Assessment (CCRA) that have been identified as a priority for Scotland over the next five years. The

Adaptation Programme will address the risks to Scotland, identified in the CCRA, relating to all matters not expressly reserved to the UK.

- 3.4 The Programme has an overarching aim to:
  - Increase the resilience of Scotland's people, environment, and economy to the impacts of a changing climate.
- 3.5 The programme is structured around three main themes:
  - **Climate Ready Natural Environment** A Scotland with a productive, healthy and diverse natural environment which is able to adapt to change.
  - Climate Ready Buildings and Infrastructure Networks A Scotland with wellmanaged, resilient infrastructure and buildings providing access to the amenities and services we need.
  - **Climate Ready Society** A Scotland with strong, healthy, resilient communities which are well informed and prepared for a changing climate.
- 3.6 Each theme contains objectives and the policies and proposals to address the relevant risks identified by the CCRA and to drive the progress towards meeting the objectives. The objectives describe what is hoped will be achieved in the long-term (up to 2050). The questions in the consultation document attached (**Appendix I**) are relating specifically to those themes e.g. The Overarching Framework, Natural Environment (Objectives N1, N2 and N3); Infrastructure and Built Environment (Objectives B1, B2 and B3); Society Theme (Objectives S1, S2 and S3). The consultation document also asks for views on the Environment Report that assessed the Adaptation Programme. The themes and Objectives are outlined in the table below:

	Comments: The three themes in the overarching aim <i>almost</i> mirror a sustainable development approach to adaptation to climate change impacts. However, the economic strand of sustainable development has not been addressed sufficiently. Many of proposals within the programme require a strong economy in order for those actions to be implemented.
	Clear, easy to understand diagram. Would use 3 different colours for each section as the three blue looks quite dull.

	Comments: The overarching framework goes a long way towards addressing the current and predicted impacts to Scotland indentified in the UK Climate Change Risk Assessment. However, there is so much uncertainty surrounding predicted impacts that there needs to be a degree of flexibility in the adaptation programme in order to address unpredicted effects and impacts.

There is also a scant mention of the National Biodiversity Strategy and absolutely none of local Biodiversity Partnerships. I realise this is the National Strategy but perhaps these should be tied I somehow?

Will marine planning partnerships still have a local enough focus to be able to influence and facilitate local awareness raising, projects and collaboration with local authorities, partner agencies etc?

Impacts on more erratic water supply for heavy water users, water bottlers and those with their own supplies.

Comments: Refer to Coastline Management Plans – particularly with reference to strategic routes such as the east coast rail line.
Generally need to disseminate information to all concerned – for example use of design to adapt to changing climate, micro siting etc.
Doesn't seem to address heat issues – cooling, heat mapping and district heating systems to reduce demand and use energy more efficiently, reducing waste heat.

Ensure development avoids locations and designs that exacerbate the effects of climate change such as development in undeveloped floodplain, using surfacing the creates increased run off and adds to the potential for flash flooding on flooding on adjacent properties.

No reference to BU6, BU7, HE3, HE5 and HE6 being tackled by any actions.

Objective refers to raising awareness of the impacts of climate change to enable people to adapt to future extreme weather events. However, the policies and proposals quite sensibly tackle climate change in general, as opposed to specifically extreme weather events.

In addition, gathering the information is useful, however sharing it with communities during times of extreme weather events may prove difficult and there should be a more robust strategy to ensure that the information "gets out there" in the absence of electronic communications.						
Policy/Proposal S2-7 is the key to the success of this objective and should be adequately resourced.
