Spaces are 10' across and 10' deep. (Please include the tongue in length of trailers) Each additional foot up to 9 feet will be \$15/ft. Vendors needing 10 additional feet will need to purchase a second booth. There will be no refunds after you are accepted. Water and gray water disposal will be the only things included with your fee. We will not provide grease barrels. You will need to take it with you. Any dumping of grease is a federal crime and will be treated as such. You will need to bring your own food grade water hose; three-way hose connector and back flow preventer. You will be responsible to contact the Onslow County Health Department (910-938-5851) to obtain a Temporary Food Stand Permit.
