The FSAs move to extend the approved persons regime to the mortgage sector will have a major impact on any firm where individuals advise on, arrange or enter into home finance business. Individuals that give mortgage advice as well as those that arrange mortgages on a non-advised basis will become personally accountable under the proposed new customer function, CF31. The compliance oversight function (CF10) will also be extended to home finance activities.

The near final rules were published in June to give firms time to prepare for implementation. Final rules are due to be published in September 2010.

Workshop objectives

- Approved persons regime in relation to home finance (mortgage) activity , including CF10, CF31 and exceptions
- Implementation timings
- FSAs approval process
- Fit and proper test
- Obligations and responsibilities of being an approved person (Statements of principles/ Code of Conduct)

- Systems and controls
- Recruitment process and T&C framework
