ADMISSION APPLICATION INSTRUCTIONS

SYRACUSE UNIVERSITY COLLEGE OF LAW

- Complete and submit the admission application form together with the \$75 application fee. The application fee is neither refundable not will be credited toward tuition and fees
- 2. Take and obtain a score on the Law School Admission Test (LSAT) and register with the Credential Assembly Services (CAS). Registration for the LSAT and CAS can be completed through LSAC at LSAC.org or by telephone at 215.968.1001
- 3. The College of Law recommends that you take the LSAT no later than February of the year prior to the year you wish to enroll. Scores from the June test will be considered, but may delay the admission decision. LSAT scores cannot be more than five years old (test date in 2010 or later).
- 4. Submit transcripts of all previous college or university study through the Credential Assembly Services (CAS). Graduate and prior law study transcripts also must be submitted through Credential Assembly Services. Failure to submit all transcripts will delay review of your application.
- 5. Applicants are strongly encouraged to submit up to three letters of recommendation. Statements from persons familiar with your qualifications for the study of law, especially professors under whom you have studied, often prove helpful. If you are currently in an undergraduate or graduate program, or have recently completed one, the Admissions Committee will expect to see letters of recommendation from professors under whom you have studied.

We recommend that applicants submit letters of recommendation through the LSAC Letter of Recommendation Service (refer to LSAC.org for details). Letters of recommendation are also accepted directly from the recommender. If it is sent this way, recommenders should use the appropriate letterhead and send to the College of Law with their signature across the sealed envelope. The College of Law will accept evaluations through the LSAC Evaluation Service. Evaluations are not required, nor should they be used in place of letters of recommendation.

- 6. If you are an undergraduate Juniorm applying trough an approved 3 + 3 program, check the box for "3 + 3 program candidate".
- 7. Transfer and visiting student applicants must submit the additional documents outlined on the College of Law web site under Transfer Admissions.
- 8. Applicants who are not U.S. citizens must submit all materials required of domestic applicants as well as the additional documentation outlined on our web site under Applying as an International Student. This documentation includes educational records, TOEFL, proof of financial support, and sponsor letter.
- 9. If you are interested in a joint degree program, applicants must apply separately to the College of Law and to the other Syracuse University graduate program. Joint degree applicants may have to take additional standardized tests, such as the GRE or GMAT. Application information and supporting documentation submitted to the College of Law will not be shared with or photocopied for other Syracuse University departments. In addition, joint degree candidates should be aware that consistent with Law School Admission Council policy, LSAT scores may be used for purposes of admission to law schools only. The College of Law and Credential Assembly Services (CAS) will not report LSAT scores to other graduate departments. Candidates should request the Syracuse University graduate application from Syracuse

University, Office of Graduate Admissions, at telephone 315.443.4492, or may find it online at www.gradsch.syr.edu.

- 10. The deadline for receipt of application materials is April 1 to be considered for admission in the fall semester of the same year. An application is complete and ready for review after the College of Law receives the completed application forms and the Credential Assembly Services (CAS) report from LSAC. We suggest that materials be submitted through the Credential Assembly Services by February 15 to enable the Credential Assembly Services to compile and submit them to the College of Law before the April 1 deadline.
- 11. Admission applicants will be contacted by the College of Law Financial Aid Office with instructions on how to apply for need-based financial aid (such as College of Law Grants and Federal Loans). A Financial Aid "To Do List" will be assigned on www.MySlice.syr.edu, the university's webportal. To apply for need-based aid, complete "initiated" items by the priority deadline: February 15.

Merit scholarships are awarded without regard to financial need. All candidates will be considered for scholarships through the admission application process.

- 12. It is your responsibility to make certain that all necessary materials and credentials are received by Law Services and the College of Law in a timely manner. You should retain for your records copies of all correspondence forwarded to LSAC and the College of Law, including your admission application forms, financial aid application forms, and all attachments and enclosures.
