Recent changes have produced confusion and many questions. This two-day seminar will provide basic training for new preparers and complete coverage of new and complex issues for experienced preparers. Bankers with responsibility for the entire report should attend both days. Day Two offers training to those with responsibility for only the Lending Schedules.

In January 2014, the regulatory agencies finalized several changes to the Call Report to provide additional data for safety and soundness or other public purposes. The effective date of most of the changes will be March 2014. Basel III has been approved and the regulatory changes to Risk Weightings and Capital will affect the call report. Additionally, any subsequent changes proposed by the regulators affecting the 2014 call report will be covered in the session. The FFIEC 041 forms will be used in the presentation and materials.
