Specific observations and overall impression on the MSR and the quality of facilities

The compliance verification inspection of Govt Medical College, Surat was carried out on 14th May 2011 which was extended on 15th May by undersigned assessors vide letter no MCI-37(1)/2011-MED/9988 dated 12-05-11.

The deficiencies which were pointed out in the last inspection dated 26th to 28th Feb 2011, in lecture theatres, auditorium, examination hall have been rectified. The departments of physiology, Biochemistry & Pharmacology facilities are now adequate. The new faculty, residents & Asst Nursing Supt. & Deputy Nursing Supt have been appointed. The teaching faculty deficiency has come down from 6.6% to 3.87% The lady medical officer at UHC & RHC are now under Dean, Govt Medical college, Surat. The new OT block with MICU & RICU are in advanced stage of construction. The equipment are already procured. The overall facilities of infrastructure and teaching are adequate and as per MCI norms for 150 intake.

The compliance by the college has been verified point wise and observations by the assessors are attached as annexure 1.
