**CONDITIONS OF AGREEMENT:**

1. By signing this contract, you authorize your current employer to pay your WRAC membership dues through payroll deduction. A house account will be set up for other club services you choose to utilize.
2. An e-statement will be sent at the beginning of each month to email given at time of enrollment. Membership account payment must be received at the club by **the 25<sup>th</sup> of the month**. Any unpaid balance after the 25<sup>th</sup> day of the month will automatically be charged a **\$15 Late Fee**. Accounts with returned payments for **Non Sufficient Funds** will be charged **\$20 fee**.
3. Employee authorizes payroll deduction to be adjusted for all future changes in dues, either because of changes requested in membership type or level or in monthly dues increases for which a 30 day advance notice by the club is given.
4. **Corporate membership termination requires completion of Member Cancellation Notice prior to the 10<sup>th</sup> of the month to be effective at the end of the month.** If notification of termination is received after the 10<sup>th</sup> of the month, termination will be effective at end of the following month.
5. Payment of the initiation fee, current month dues and submission of this signed enrollment form are required to start your membership.
6. If your employer does not continue to offer this benefit or if you leave employment, you may choose to either terminate your membership or continue membership with payment of regular dues. Notification to the club is required to make this change.
