Fetha Styx carries a limited lifetime warranty against defects in materials and workmanship for the original purchaser/owner. If your rod fails, ship the entire damaged rod in a disposable container – prepaid and insured at your cost. If the rod has failed due to a manufacturer defect we will pay the return shipping costs with no additional charges.

- If the problem is due to a defect in materials or workmanship, the rod or rods will be replaced for you as soon as possible.
- If the damage is due to an accident, misuse, normal wear and tear, or modification/customization of the finished rod, the rod will be evaluated and we will quote you the cost of repair or replacement. We will await your approval before proceeding.
- Please allow 10 business days for processing in order to provide you with optimal service.
- Fetha Styx reserves the right to determine whether to repair or replace any Fetha Styx product covered by this warranty. If a product happens to be discontinued, Fetha Styx will replace with a comparable model determined by Fetha Styx. Please be aware that components and colors may vary between original and replacement parts.
- No upgrades or exchanges on damaged rods.
