HIPAA Privacy & Security: The Next Wave

Purpose:

Although HIPAA compliance has now been a topic of discussion for years, anecdotal evidence suggests that policy does not always follow with practical application. Participants will be reminded of existing HIPAA-compliant requirements with a practical discussion of how policy and practice often vary. The challenge of implementing policy and building in audit processes within your organization is now taking on greater meaning as various regulations stemming from the Recovery Act bill impose greater requirements on the communication and protection of patient confidential data. Many of these changes are to be in force by February 17, 2010. New Requirements regarding disclosure of a breach, business associate liability and the right of a patient to place limitations on the distribution of his/her health information will be discussed. All of these requirements take on enhanced meaning when considering that government audit procedures are now mandated for the first time and greater financial penalties are on the horizon. Related initiatives that are likely to increase the need for vendor interaction with patient confidential data and BAAs further complicate the picture. Hospitals are incentivized to implement an Electronic Medical Record, Level 1 5010 compliance is required by the end of this calendar year and the incorporation of ICD-10 is likely to impact virtually every dataset and business process within the hospital.
