



## STEP ONE: Acquire Your Official Invitation

All applicants must submit an official invitation from Russia. (Invitation letters written by business contacts may be used only for the Three Year Visa process; contact G3 for details.)

- If you do not have your own invitation, G3 can acquire tourist and business invitations; please see the attached Invitation Order Form. Processing times listed on the Applicable Fees page do not include invitation processing time.
- If you have your own invitation, provide a scan. This must be the official invitation from Russia, which will be written in Russian; samples are attached. If your invitation is a Telex sent directly to a consulate, you will need the reference number, the name of the company that requested the invitation, the cities to be visited, the entry and exit dates listed on the Telex request, and the date it will be available at the consulate. Rejections due to incorrect Telex details will be subject to additional Submission Fees. You will need to have the details of your invitation before your Russian Visa Application can be prepared.

## STEP TWO: G3 Prepares Your Russian Visa Application

Due to the complexity of the online Russian Visa Application, all applicants are required to use G3's Concierge Level Service to have a G3 associate complete the online application. Email the following documents to [CLS@g3visas.com](mailto:CLS@g3visas.com):

- ☐ Completed Russian Visa Questionnaire (attached). You may save your answers on this file and email directly to G3. All questions must be answered in full in order for G3 to complete your application accurately.
- ☐ A scan of the information/photo page of your valid signed passport.
- ☐ Your completed Visa Order Form (attached).
- ☐ Your completed Invitation Order Form, or if you will provide your own invitation, send a scan of your official invitation or your complete invitation Telex details.
- ☐ If you have previously visited Russia, send a scan of all your previous Russian visas issued within the last three years.

G3 will email you a PDF of your completed application to print and sign, as well as a pre-paid FedEx airbill to send your documents to G3. Please allow 3 business days for your application to be completed after G3 has received all information. Rush service is available.

## STEP THREE: Send the Following Documents to G3

- ☐ Your completed Russian visa application, sent to you by G3, printed and signed with a pen-to-paper signature in blue or black ink. Make sure the signature matches the signature in your passport.
- ☐ Your original valid signed passport. It must have at least two blank pages marked "Visas" side by side and more than six months before expiry. (G3 can assist with expedited passport renewals and additional passport pages.)
- ☐ One passport-style (2"x2") photograph taken within the last 6 months (must be in color, on photo paper, and have a plain white background).
- ☐ If providing your own invitation, send a hard copy of the invitation or Telex details. Multiple Entry applicants must send the original paper invitation from Russia.
- ☐ Copy of flight itinerary, showing your name and entry and exit dates.

### Additional Requirements for Select Applicants:

- ☐ Minor visa applicants must also provide a copy of their birth certificate showing both parents' names, copies of both parents' passports or driver's licenses, and an original letter signed by both parents giving permission for the child to travel to Russia.
- ☐ Non-US citizens must provide a copy of their valid Permanent Resident Card or U.S. Visa and I-94. Travelers who entered the US after April 26, 2013 should print the electronic I-94 form from <https://i94.cbp.dhs.gov/>.
- ☐ European Union citizens must also submit proof of health insurance valid in Russia (copy of valid health insurance card or confirmation of purchase of travel insurance, along with a policy statement showing applicant's name and validity in Russia).
- ☐ Former citizens of CIS nations (former USSR) must submit a copy of their previous CIS passport or other proof they do not hold Russian citizenship.
- ☐ Work, Residency, or Student visa applicants must also include a copy of HIV test results issued within the past 90 days.
- ☐ Business visa applicants over age 65 must submit a letter from their company verifying their employment.



## VISA NOTES

- Multiple entry visas require two signed applications and two photos. If providing your own invitation, the original paper invitation must be submitted. Multiple entry visas are issued for business only, and allow no more than 90 days stay in any 180 day period.
- Tourist visas are valid for no longer than a 30 day stay. If you require a longer stay in Russia, please apply for a business visa.
- If you are in need of a Flight Crew visa, please email [FlightCrew@g3visas.com](mailto:FlightCrew@g3visas.com).
- All travelers must register their visa within 7 business days of entering Russia. Most hotels provide this service for free, but the registration is valid only for the period of stay in the hotel. If you will not be staying in a hotel, visas may be registered at a local office of the Russian Federal Migration Service or at the office of the tourist company which issued the invitation.

## PROCESSING NOTES

- Send all required documents and the completed Visa Order Form to G3 using a service with tracking such as FedEx or UPS.
- Due to submissions deadlines set by consulates and agencies, documents received by G3 after 8:30 am are hand-carried to the appropriate processing facility the next business day. 8:30 am delivery is recommended for requests requiring Mission Critical service; the signature requirement must be waived on 8:30 am delivery packages.
- Consular Fees include a \$5 Money Order fee and a non-refundable \$35 Submission Fee.
- Credit card payments are subject to a 5% credit card convenience fee unless the physical card is presented in person.
- CLS and Invitation Fees are charged at the end of Step Two, and will be invoiced separately from Consular, G3 Processing, and Return Delivery Fees. CLS Fee is non-refundable after the application has been completed; Invitation Fee is not refundable after G3 places the invitation request in progress.

- The issuance of visas, including visa duration and number of entries, is at the discretion of the Consulate.
