REGULAR MEETING

APRIL 14, 2014

The fourth regular meeting of the Mayor and Council of the Borough of Ogdensburg, Sussex County, New Jersey was held in the Council Chambers of the Borough Hall on April 14, 2014. Mayor Ciasullo called the meeting to order at 7:00 p.m.

Upon roll call, the following Council members appeared and answered the call: Hutnick, McGuire, Opilla, Rizzo (arrived late.) Absent: Amodeo, Astor . Also in attendance was Borough Attorney, Michael Garofalo.

Notice requirements of the Open Public Meeting Act NJSA 10:4-6 et. Seq. have been satisfied with a schedule of all meetings, together with the time, location and agenda of same being sent to the NEW JERSEY HERALD and NEW JERSEY SUNDAY HERALD and posted on the bulletin board on January 2, 2014.

Councilman McGuire moved, Councilman Hutnick seconded motion to approve all items on the consent agenda.

Councilman McGuire moved, Councilman Hutnick seconded motion to adopt the following resolution.

BE IT HEREBY RESOLVED by the Mayor and Council of the Borough of Ogdensburg to accept the proposal by Prism Maintenance, Inc. in the amount of \$6,500.00 for power sweeping approximately 19 road miles through out the Borough of Ogdensburg.

Unfortunately the dates she asked for are already taken and she would have to pick other times.

OLD BUSINESS

Council spoke about health benefits for employees. Council asked if an employee who is technically married but not living with spouse if the Borough is obligated to cover the spouse and if there is a child from a previous marriage is the Borough obligated to cover the child from the first marriage of the spouse. Borough attorney said he would look into it. Council spoke about the codification of ordinances and will be reviewing packet they received on the ordinances. Mayor spoke briefly about shared services with the Court. They went over all the paper work and will have more details after the next meeting. Councilman McGuire informed Mayor and Council that there are 145 meters left to be installed and also some bad valves.

about the pre-construction meeting on the Main Street Streetscape. The Mayor met with the County, PSEG, Borough Engineer, Construction Manager and the Land Use Chairman and everything is ready to go and there shouldn't be any issues. The only thing is that the street lights are going to be a little delayed but they have been ordered.

David Giunta from Class Act Casino Events attended the meeting to discuss a possible fund raiser for the 100th Anniversary. The Borough would need to get 100 people for a Casino Night. Mr. Giunta also explained other types of fund raisers.

NEW BUSINESS

Mayor briefly mentioned that an ordinance was done for the Main Street project and also a resolution. There was some confusion as to whether the Finance Dept. received the resolution or not. The situation will be looked into to see if anything further needs to be done. Council has not set a date yet as to the opening of Heaters Pond. The date will be posted on the board at the fire house. Council briefly discussed the hiring of lifeguards. Mayor Ciasullo informed Council that seasonal employees are able to collect unemployment and spoke about different options to hiring lifeguards. Further discussion will be forth coming. Mayor Ciasullo asked about a person who put in an OPRA request and wanted it e-mailed. The copy that was e-mailed wasn't that clear so it was requested again and was picked up. Does the Borough have the right to charge for the second copy? The attorney informed the Mayor that the Borough can charge for the paper copies.

Councilman Hutnick moved, Councilman Astor seconded motion to open the public session of the meeting. Yeas: Astor, Hutnick, McGuire, Rizzo.

Vicky Schroeder, 60 Center Street a school representative attended the meeting to discuss the proposal for a new school sign. The school is looking into getting a new sign and what they are looking for is an electrical sign which could also be shared with the Borough. The school is asking if the Borough would be interested in going in on the cost of the sign. The cost would be \$15,000 and the Borough would also have access to using the sign. One of the council members said he could look into it and maybe find something at a better price. Ms. Schroeder also mentioned that she has literature on fund raisers and offered if the Borough needs help. Christopher Peterson from Scout Troop 87 spoke about his project that he has been working on for Heaters Pond. Chris mentioned that he has the paint ready and would like to start painting during his spring break. Councilman Hutnick also offered to help with the project. Cliff Lowe, 18 Richards Street spoke about Franklin Day and the use of the Littell Center. It was also mentioned that two yards of clay were given to Franklin for their fields, which they needed.

There being no further business from the public, Councilman McGuire moved, Councilman Astor seconded motion to close the public session of the meeting. Yeas: Astor, Hutnick, McGuire, Rizzo.

Councilman McGuire mentioned about having an ice cream vendor at the 100th Anniversary celebration.

Councilman McGuire moved, Councilman Hutnick seconded motion for review and payment of vouchers. Yeas: Astor, Hutnick, McGuire, Rizzo.
