INSTRUCTIONS FOR THE APPLICATION FOR APPEAL

Filing Deadline: File this form **within 60 days** of an applicant's notification of SCRIE denial.

Who can Appeal?

Any SCRIE applicant or recipient who disagrees with a SCRIE denial or revocation notice can file an Appeal.

Is there a deadline for having an order appealed?

- You must ask for an appeal within 60 days of the date listed at the top of the order.
- Finance will accept your appeal if it is postmarked less than 60 days after the date of the order.
- Finance may, if you have a good reason, extend your time to appeal based on your written request.

How do I file my appeal?

Please fill out the form and attach a copy of the SCRIE order that you are appealing.

What happens to the order while it is being appealed?

 The order under appeal remains in effect while Finance reviews it.

Specifically, the Administrative Code of the City of New York provides that:

Any landlord who collect(s) or seeks to collect or enforce rent from a tenant in violation of the terms of a rent exemption order shall for the purposes of all remedies, sanctions and penalties provided in this title be deemed to have collected or attempted to collect or enforce a rent in excess of the legal regulated rent.

Can a Court review the SCRIE Order?

A court cannot review a SCRIE order until you go through the SCRIE appeal process. If you disagree with the results of the SCRIE appeal process, you may then appeal to the New York State Supreme Court.

Don't forget to attach a copy of your SCRIE denial or revocation notice plus copies of all documents that support your claim.
