

Missing Child Information Form



In the event of a disappearance of your child, after calling police, fill out, or have another family member of friend fill out this form as completely and accurately as possible. In such a difficult time as this it will be difficult to concentrate on tasks, but keep in mind that this information might prove vital to finding your child. Keep this with the brochure, the Child's Personal Information Form, and a current identification kit. Use additional sheets of paper if needed.

LIST, IF KNOWN, NAMES OR DESCRIPTIONS, INCLUDING VEHICLES, OF ANY PERSONS WHO HAVE BEEN IN, AROUND OR NEAR YOUR HOME FOR REPAIRS, REMODELING, SERVICING, INSTALLATIONS, UTILITY COMPANIES, DOOR-TO-DOOR SALES, DELIVERIES, OR OTHER SUCH ACTIVITIES RECENTLY. INCLUDE THE ORGANIZATION'S NAME, IF KNOWN.
HAS ANYONE YOU KNOW, INCLUDING FAMILY, MADE INAPPROPRIATE COMMENTS TO YOU OR THE CHILD, OR TOUCHED THE CHILD INAPPROPRIATELY? IF SO, EXPLAIN AND GIVE NAME, ADDRESS AND PHONE.
HAS THE CHILD BEEN BEHAVING IN ANY WAY OUT OF THE NORM RECENTLY?
ARE ANY OF THE CHILD'S BELONGINGS (INCLUDING PETS) MISSING?

GIVE THIS FORM TO POLICE, OR FILL IT OUT WITH THEM AND GIVE THEM THE CHILD'S PERSONAL INFORMATION FORM, AS WELL.
