2008 Convention Speakers

Lisa Maatz is AAUW's Director of Public Policy and Government Relations. As the organization's top policy advisor, Maatz works to advance AAUW's priority issues on Capitol Hill, working through the executive branch and in coalition with partners from the education, women's and civil rights communities. In 2006-2007, she also served concurrently as the Interim



AAUW Legal Advocacy Fund Director. Maatz came to AAUW from the NOW Legal Defense and Education Fund, where she was Vice President for Government Relations. She is a Phi Beta Kappa graduate of Ohio University and has earned two Masters degrees from Ohio State.

Maatz will be the keynote speaker at Saturday's dinner speaking on "How You Can Make a Difference in the Political Process." She will talk about how AAUW's member-adopted Public Policy Program is implemented, offer advice on what can be done to support AAUW priority issues, and discuss effective strategies for grassroots advocacy in the community. She will discuss critical women's public policy issues currently moving through Congress and what's at stake in the 2008 election for women. She will also share her experiences in helping AAUW to further legislation that supports opportunities for women and their families. After dinner Maatz will hold a forum titled "AAUW Public Policy Q&A".

Earlier on Saturday, Maatz will present a workshop entitled "Techniques to Mobilize Women Voters in 2008 and Beyond."



Mary Baird is the President and Chief Executive Officer of The Ophelia Project, and has been involved with the project http://www. womensway.org/events.asp since its inception in 1997. Baird received her master's degree in Health Education and remains committed to promoting the health and well-being of children and adults across the country. In her critical teen years, Mary was raised by

a single parent and surrounded by a strong and supportive network of women role models. She developed a passion for helping others and a realization that adult mentors can have a critical and positive impact on young people. She spent her earlier professional career in intensive care nursing, health instruction and college nursing, along with experience in an adolescent psychiatric hospital. Mary brings organizational skills and curriculum development expertise to all programs of the Ophelia Project.

As The Ophelia Project's first Executive Director, Mary cemented the network of relationships with agencies, professionals and institutions necessary for the organization's success. She maintains contact with groups and individuals within the Erie community and across the country.

Mary is a skilled and engaging speaker and trainer. Within the past 5 years she has been involved in over 30 national speaking engagements or trainings for The Ophelia Project.

As President/CEO she is responsible for directing all facets of The Ophelia Project, including management of all Ophelia programs and administrative activities, assisting with the coordination of national fundraising, public relations and marketing efforts, and working collaboratively with The Ophelia Project's board of directors.

Sebronette Barnes has

performed on concert, recital, and opera stages throughout the United States and Europe. Described as " ... a fine, communicative singer with a rich voice and considerable stage magnetism" (*Cleveland Plain- Dealer*), she has appeared with the Cincinnati Opera, Opera Columbus, the Toledo Opera, and the Rome Opera Festival. Her association



with the New York Harlem Opera Theatre in Gershwin's *Porgy* and Bess led to performances in Austria, Belgium, France, Germany, Holland, Luxembourg, and Switzerland. She appeared with the Opera Company of Philadelphia in the east coast premiere of Margaret Garner. Barnes has performed at the National Underground Railroad Museum, the Kentucky Center for the Arts, the National Afro-American Museum and Cultural Center, the Dayton Museum of Art, and the Philadelphia Museum of Art. She can be heard on the recording of Gershwin's Porgy and Bess with Erich Kunzel and the Cincinnati Pops (Telarc).

In 1998 Barnes received funding from the American Association of University Women for her project *The Life and Music of Margaret Bonds: You Can Tell the World*. This set the stage for this fellow to present lecture-performances at various national conferences culminating in a grant from the PA State System of Higher Education for a recording of songs by African American women composers You Can Tell the World: Songs by African-American Women Composers (Senrab).

Barnes holds degrees from Jackson State University (B.M.E.), Miami University (M.M.), and The Ohio State University (M.A., Ph.D.) and has done additional study at the College Conservatory of Music of the University of Cincinnati, the American Institute of Musical Studies, Graz, Austria, and the International Institute for Vocal Arts, Chiari, Italy. She has served on the music faculties at Miami University, Oxford, Ohio and Indiana University of Pennsylvania and is currently a tenured, associate professor in the fine arts department at Cheyney where she serves as chair and director of the Arts and Lecture Series. She is on the board of Sankofa Academy Charter School in West Chester. Barnes is Co-Vice President for Program and Diversity Chair for the West Chester-Chester County Branch. In 2006 she was the chapter's Outstanding Woman.

Preconvention Outing

The pre-convention outing will include visits to the **Brandywine River Museum** and the **N.C. Wyeth House and Studio**, both handicapped accessible. The shuttle will leave the Inn at Chester Springs at 1 pm on Friday and travel to the museum, arriving about 1:30 pm. Half of the participants will receive a guided tour of the museum, while the other half will go by shuttle the short distance to the Wyeth House for that guided tour. Approximately 1 hour later, the two groups will switch places. The Brandywine River Museum, operated by the Brandywine Conservancy, is a Civil-war era gristmill on the Brandywine River that has been converted into an outstanding art museum, internationally known for its collection of works by three generations of the Wyeth family and of American illustration, still life and landscape painting. The N.C. Wyeth House sits on 18 acres of land overlooking the Brandywine Valley.



Meet the Candidates

Kate Sweeney Co-president

Kate joined the Makefield Area Branch in 1994. She has served as that branch's Co-President/President



(1998-2002) and in several community action leadership roles (1998-2007) - Sister-to-Sister Summits, voter drives registering high school seniors, Girls' Recognition dinners honoring 7th grade girls in science and math excellence, and annual fundraising for EF/LAF and local scholarships. At the state level, Kate has served as District Coordinator (Southeast) and created and coordinated the effort for surveying members about changing to a Biennial State Convention - which became a reality at last year's state convention. Kate has served as a muchrespected mentor to state board members and you can always count on her to help out when it comes to AAUW projects.

Kate has a B.S. in early childhood education from Chestnut Hill College. She was a third grade teacher and Chapter One reading specialist in the Central Bucks School District from which she retired. Prior to her teaching career, Kate worked for Drexel Burnham Lambert Investment Banking, Registered Series 7 (San Francisco) and was co-founder and executive director of Project Insight, Inc. (San Francisco).

In response to the question of what she sees as the primary focus of AAUW-PA and how would she use her position to work toward that goal, Kate writes: "For me, the focus of AAUW-PA is twofold: to manage what has already been built and to communicate change effectively between Association and PA branches.

"AAUW is well established in its research, mission-based initiatives, and leadership training. It is sufficiently current in use of technology. The state board would continue to facilitate branch use of these AAUW opportunities emphasizing the Woman-to-Woman Voter Turnout Campaign in this election year.

"Changes to AAUW's organizational

structure, cost management, and mission relevance are occurring alongside shifting branch membership. Current rolls reflect a senior guard with limited energy and expanded personal interest time. These members support but differ from younger rank and file women who, at high points in their career and family development, have boundless energy and seek involvement in worthy community projects. It is AAUW-PA's role to support members and leadership, keeping everyone informed of the other.

"My intention, working with Deb Roney as co-president, will be to provide branches with existing materials, as well as communicate back and forth the changing business of Association and PA branches. We are after all one in the mission of AAUW advancing equity for women and girls through advocacy, education, and research."

Deb Roney *Co-president*

Deb joined the Huntingdon branch in June 1989 and the following fall began her branch leadership as Education Chair. In 1992 Deb's projects as part of the AAUW

Project 21st Century Initiative – a program on gender-free toys and games for parents of preschoolers, Career Fairs for 5th and 8th grade students, and Career Shadowing for 5th and 10th graders – won the 1992 PA Impact Award. Deb has co-chaired two Sister-to-Sister Summits (1991 and 2001), the second of which was funded by a grant from Association, and won the 2002 Pennsylvania Impact Award. She has also served as branch President, Program Vice President, and Public Policy Chair, and in 1991 was named branch Outstanding Woman. Deb has served on the state AAUW board as the South-Central District Coordinator (1992-1995), Public Policy Chair (1999-2002) and Bylaws Chair (2006-present).

Deb is a graduate of Dartmouth College with a B.A. in Russian, Ohio State University with an M.A. in Slavic Languages and Literatures and a Ph.D. in Slavic Linguistics. She is Director of Language in Motion and assistant professor of English at Juniata College in Huntingdon. Deb has served as a visiting lecturer in Russian and Polish language, literature, and linguistics at Ohio State University and the University of New Hampshire as well as a title translator and proofreader. Deb's Language in Motion project was funded by The Arthur Vining Davis Foundation in 2004 and this program has been additionally recognized by the PA Council for International Education, NAFSA: Association of International Educators, and the Institute of International Education. Deb's community services include Chair, Huntingdon Area School District Gifted Curriculum Steering Committee, 1999-2003 and Secretary of the newly formed Huntingdon Soccer Club, 2004-present.

In response to the question of what she sees as the primary focus of AAUW-PA and how would she use her position to work toward that goal Deb writes: "AAUW-PA's efforts should: 1) encourage and assist branches in supporting our mission, 2) facilitate communication between Association, branches, and members, and 3) get out the vote.

"Branches and individual members are the keys to our success, and across the state we implement wonderful, missionrelated ideas that improve lives. Statelevel programming should creatively tap these strengths and facilitate our members' growth. We must continue to share our ideas and the motivation to tackle them, and the revised state annual meeting structure provides new opportunities.

"Additionally, the state serves as an important communication channel between Association and members. Members will want the recent changes explained and the opportunity to comment; the state should facilitate these conversations.

"Finally, at stake in the upcoming elections are several mission-related issues that affect the quality of women's lives and those of their families. AAUW-PA is well positioned to impact voter turnout this spring because of the campaign grant



from Association that will fund our efforts. Additional work will be necessary to ensure both public discussion of our issues and an educated electorate who goes to the polls. Our efforts will further our mission and get our name before thousands of potential new members across the state."

Sara Barron Program Vice

President

Sara has been a member of the Johnstown Branch since graduating from college in



1983. She was editor of *Inclined to AAUW* for 9 years. Sara has also done short stints as Corresponding Secretary and as Treasurer of the branch. She is currently Program Vice President. Sara joined the state board in 2005 as Conference Coordinator and continues to serve in that position as well as on several state board committees. Sara has ably fulfilled her role as Conference Coordinator.

Sara has a B.S. in business administration with a major in accounting from Clarion University. She is currently employed as an accountant by Cambria Residential Services, a non-profit provider of housing and services to mentally challenged adults. She also runs Creative Fabrications, her three-year-old home-based window treatment business, on the side. From 1988 to 2004 she was the accountant for the Johnstown Area Heritage Association. While at the Heritage Association, she was heavily involved in the planning and management of the Johnstown FolkFest, a regional music and food festival. Sara's community work includes treasurer of United Way of the Laurel Highlands (1987-present), and secretary and marketing chairperson of the YWCA of Greater Johnstown (2002-2004).

In response to the question of what she sees as the primary focus of AAUW-PA and how would she use her position to work toward that goal Sara writes: "AAUW-PA has to be responsive to branch needs. I see the state board providing training, tools and practical ideas that local branches, even small ones, can use to improve the lives of women and girls. Association has trouble relating to branch level issues. AAUW-PA can provide realistic suggestions and help bridge the gap between rhetoric and reality.

"I think that interesting, thoughtprovoking, pro-active programming is the key to making and keeping local branches viable. As Program Vice President I want to build on work done in recent years to help busy branch program officers put together programs and projects that will further our mission and attract others to help us advance our goals for the future.

"21st century program officers need to do more than organize an annual series of speakers to entertain at branch meetings. I want to help local branches find ways to move beyond social meetings and really engage their members to advance equity in ways that fit their members' interests, capabilities and skills. My goals are to provide more and better program tools and ideas through our website, and in district and state meetings."

Proposed Changes to AAUW-PA Bylaws - Convention 2008

There are two proposed changes to the bylaws to allow for job-sharing by coofficers at the state level (*proposed additions are in bold italic; deletions are indicated by strikethroughs*):

A. Page 3: Article VII ("State Officers"), Section 1

The elected officers *or co-officers* shall be a president, program vice president, membership vice president, secretary and finance officer.

B. Page 6: Article XII ("Board of Directors"), Section 6

The quorum for a meeting of the board shall be a majority of the voting members. *Co-officers shall be considered as one voting member of the board.*

NCCWSL Scholarships

Spreading *Let's Read Math* Seeks Additional Branches

Applications are now being taken under the second year of the grant. Branches in the Middle Atlantic Region are eligible. Volunteers need not be members, but an AAUW branch must administer the program.

Our **Celebration of Women Buffet** will have an oriental theme.
