A hearing was held before the Presiding Judge or an affidavit was submitted and the Court waived hearing on this matter. After full consideration of the evidence, the Court finds the material allegations of the Complaint for Civil Union Divorce to be true. Plaintiff is entitled to a divorce from the bonds of civil union. The Court has jurisdiction to enter this Civil Union Divorce Decree.

**IT IS HEREBY ORDERED, ADJUDGED AND DECREED that:**

1. **Decree:** A decree of divorce is granted to Plaintiff. The civil union between Plaintiff and Defendant is hereby dissolved. The parties are restored to the status of single persons. Either party is permitted to enter a civil union or marry after the effective date of this Civil Union Divorce Decree.
  
2. **Effective Date:** This Civil Union Divorce Decree is effective after it is signed and filed by the Court.
  
3. **Alimony:**
  - A. Neither party shall be required to pay alimony to the other party.

Said motion may be done without further notice to the non-compliant party. Such execution by the Chief Clerk shall have the same effect as if executed by the non-compliant party.
