The parties agree as follows:

1. The Exhibitor assumes the entire responsibility and liability for losses, damages and claims arising out of Exhibitor's activities on Sharonville Convention Center premises and will indemnify, defend and hold harmless SAY Soccer and the Sharonville Convention Center, its agent, servants, and employees from any and all such losses, damages and claims.
3. In addition, Exhibitor acknowledges that SAY Soccer, and the Sharonville Convention Center, do not maintain insurance covering exhibitor's property and that it is the sole responsibility of the exhibitor to obtain interruption and property damage insurance covering such losses by Exhibitor.
4. SAY Soccer and the Sharonville Convention Center have the right to require Exhibitor to conform to the space limitations of Exhibitor's subscribed space. Exhibitor shall not cause light or noise which interferes with the use of other space by other Exhibitors. Exhibitors shall not create any dangerous or hazardous situations.
