"The greatest threat to the state's long-term economic strength is the still-unsolved transportation crisis. The root cause of the crisis has not been addressed -- the fact that sooner, rather than later, maintenance costs for Virginia's highways will leave nothing for any new initiatives." On October 5, Virginia Secretary of Transportation Connaughton said "By 2017 we will have no money left in construction." That should stir you to action. I urge you to attend our Winter Meeting in Miami where we will be loading our guns for another fight. We need your input and ideas because as soon as the meeting ends, we will be walking the halls of the General Assembly to educate legislators, and voters, about this crisis. Here's what you'll learn at the Winter Meeting:

- Federal Gridlock and the Need for Sustainable Funding: A Federal, State and VDOT Update Congress is on the verge of a "reauthorization" package. Will it fully fund the federal highway program, or are we looking at a 30% cut in Virginia? Will Governor McDonnell and the General Assembly address the \$450 million maintenance shortfall and save the state's highway construction program? Learn about VTCA's legislative strategy, and find out how you can make a difference.
- Blood in the Water: The Unions Draw Near With support in the White House, unions are flexing their dormant muscles and ramping up their efforts to organize employers. This session will discuss the latest union-friendly laws and how employers can help keep their workplace union-free.
- Staying Out of Court: Reducing Your Risk of Employee Lawsuits Employees are increasingly suing their employers. With every disciplinary action, an employer runs the risk that a lawsuit may follow. Learn the most common reasons why employees sue, how to reduce the risk of lawsuits, and how to avoid liability if you are sued.
- The New Health Care Laws: Your Business May Never be the Same The latest developments in healthcare reform will be presented along with the new compliance requirements you will need to meet. We'll project the anticipated impact of reform on the employer-sponsored market and the unintended consequences. We'll highlight the important strategic considerations for your company to effectively navigate through the uncertainty of reform.
