**Release and waiver of Liability and Indemnity Agreement**

In consideration of being permitted to compete, officiate, observe, work for, or participate in any way in the event(s) or being permitted to enter for any purpose any restricted area (defined as any area requiring special authorization, credentials, or permission to enter or any area to which admission by the general public is restricted or prohibited), each of the undersigned, for him/herself, legal representatives, heirs, and next of kin, acknowledges, agrees and represents that he has, or will immediately upon entering any of such restricted areas and will continuously thereafter, inspect such restricted area and that he finds and accepts the same as being safe and reasonably suited for the purpose of his use, and further agrees and warrants that if, at any time, he is in or about restricted areas and he feels anything to be unsafe, he will immediately advise the officials of such and will leave restricted areas:

1. **Hereby releases, waives, discharges and Covenants** not to sue the USXC, the promoter, participants, racing association, sanctioning organization or any subdivision thereof, track operator, track owner, officials, owners, drivers, pit crews, any persons in restricted area, promoters, sponsors, advertisers, owners and lessees of premises used to conduct the event and each of them, their officers and employees, all for the purposes herein referred to as "Releasees", from all liability to the undersigned, his personal representatives, assignees, heirs, and next of kin for any and all loss damage, and any claim or demands therefore on account of injury to the person or property or resulting in the death of the undersigned, whether caused by the negligence of the Releasees or otherwise while the undersigned is in or upon the restricted area, and/or competing, officiating in, observing, working for, or for any purpose participating in the event.

2. **Hereby agrees to Indemnify and Save and Hold Harmless** and the Releasees and each of them from any loss, liability, damages or cost they may incur due to the presence of the undersigned in or upon the restricted area or in anyway competing, officiating, observing, or working for, or any purpose participating in the event and whether caused by the negligence of the Releasees or otherwise.

3. **Hereby Assumes Full Responsibility for and Risk of Bodily Injury, Death or Property Damage** due to the negligence of Releasees or otherwise while in or upon the restricted area and/or while competing, officiating, observing, or working for or for any purpose participating in the event.

**Each of the Undersigned** expressly acknowledges and agrees that the activities of the event are very dangerous and involve the risk of serious injury and/or death and/or property damage, **each of the undersigned** further expressly agrees that the foregoing Release, Waiver and Indemnity Agreement is intended to be as broad and inclusive as permitted by the Law of the Province or State in which the event is conducted and that if any portion thereof is held invalid, it is agreed that the balances shall, notwithstanding, continue in full legal force and effect.

**Each of the Undersigned** agrees that he or she will be physically able to withstand the rigors of XC racing and that he or she has no medical issues that would jeopardize themselves or someone else. **Each of the Undersigned** agrees they will not consume any alcoholic beverage or mind-altering drugs before or during the event.

**Each of the Undersigned** agrees that in the event of an accident or injury they do consent to a drug test.
