#### SUBJECT: Fall 2009 and Fall 2010 Full-Time Faculty Obligation

This memo provides information to assist districts in complying with the full-time faculty requirements contained in California Code of Regulations (CCR) Title 5 Section 51025, which among other things requires community college districts to increase the number of full-time faculty over the prior year in proportion to the amount of growth in funded credit FTES.

The attached table "**Full-Time Faculty Obligation**" shows by district the final full-time faculty obligations for Fall 2008 & Fall 2009 and the projected obligation for Fall 2010. Also provided in this table is the Fall 2008 percentage of full-time faculty. In a normal year the final obligation is the lower of the advance and second principal apportionment calculations of the obligation; and the subsequent years projected obligation is based on credit FTES funded in the Advance Apportionment.

However at its November 2, 2009 meeting the Board of Governors determined there were inadequate funds to implement an increase in the full-time faculty obligation for Fall 2010, similar to what was determined last year at this time by the Board for the Fall 2009 obligation. As provided in the regulations, in such a year "the district's base full-time faculty obligation shall be unchanged. However, for the fall term of the succeeding fiscal year the district may choose, in lieu of maintaining its base obligation, to maintain, at a minimum, the full-time faculty percentage attained in the prior fall term."

This means that the final Fall 2008 obligation will continue as the final obligation for Fall 2009 <u>AND</u> Fall 2010 <u>unless</u> the district experienced a sufficient decline in funded credit FTES, which would thereby cause a reduction in the obligation. Districts may experience a decline in the Fall 2010 obligation due to the effects of the FTES workload reduction contained in the 2009 Budget Act. As noted above districts also have the option to meet their obligation in "inadequately funded" years by maintaining the percentage of full-time faculty employed in the prior Fall term. On the Chancellor's Office web page there is a display for each district of the obligation calculations made at different points in the apportionment process. These displays are available at http://www.cccco.edu FON.

Also attached is the form "**Full-Time Faculty Obligation for Fall 2009**" for the district to report actual full-time and part-time faculty data for Fall 2009 to the Chancellor's Office as required by Title 5. Please complete and return this form to us by **Monday, December 30, 2009**.
