# DINING CONTRACT TERMS AND CONDITIONS

## MINI-TERM 2014

- A. The student agrees that if attending the University of Tennessee for Mini-Term and a Dining Dollars plan is selected, he/she will make purchases in dining facilities for the entire period of the contract.
- B. Mini-Term Dining Dollars will be valid from the first day of Mini-Term classes through the last day of Mini-Term classes.
- C. **The Dining Dollars contract covers the entire period of Mini-Term, there is no prorating for late sign-ups.** Dining Dollars are forfeited if the student leaves the University or moves out of University Housing. Unused Dining Dollars expire at the end of the Mini-Term unless the student continues enrollment through summer semester. If the student continues enrollment in summer semester, Dining Dollars will expire at the end of the summer sessions.
- D. Refunds will not be given for days missed due to academic scheduling problems or trips taken by the resident for academic or extracurricular purposes. For periods of sickness or hospitalization, a refund will be granted for only those meals missed in excess of 15 consecutive meals with medical verification.
- E. Whenever possible, UT Campus Dining will assist students having special dietary needs upon receipt of a letter or dietary plan from the student's physician. Refunds or reduced rates cannot be made because of special dietary requirements.
- F. The student assumes responsibility for assuring Dining Dollars validation. Failure to pay fees or use the Dining Dollars does not constitute a release from the dining portion of the Housing/Dining contract with the university.
- G. Dining Dollars cannot be shared or transferred to another student.
- H. Students that live in selected fraternity or sorority housing may qualify for tax exemption status.
- I. All off-campus students that sign up for Mini-Term Dining Dollars must pay applicable state and local sales tax.
- J. Students that move from University Housing to an off-campus residence or are released from their Housing/Dining contract during Mini-Term forfeit any unused Dining Dollars. Students may opt to reinstate their Dining Dollars balance for the remainder of Mini-Term if they are still enrolled and pay the applicable sales tax on the balance.
