

## 2011-2012 Dependent Verification Worksheet Federal Student Aid Programs

Your application was selected for review in a process called "Verification," as indicated on your Student Aid Report (SAR). Complete this verification form and submit it to your financial aid administrator as soon as possible, so that your financial aid won't be delayed. Your financial aid administrator will help you.

What you should do

- Make copies of yours and your parent(s)' financial documents (signed Federal income tax forms, W-2 forms and/or Schedule C, etc.).
- Talk to your financial aid administrator if you have questions about completing this worksheet.
- 3. Complete and sign the worksheet—you and at least one parent.
- Submit the completed worksheet, copies of tax forms, and any other documents your school requests to any Student Services Center at any campus.
- The financial aid office will compare information on this worksheet and any supporting documents with the information you submitted on your application. You or your school may need to make corrections electronically or by using your SAR.
