### **CONTRACT UPDATES**

MPEA SECURITY: MPEA Security Officers, Fire Safety Officers, Supervisors, Shift Commanders and Trolley Drivers voted on April 15 to ratify a five-month contract extension.

The current three-year contract, which was set to expire June 30, will remain in place in its current form until Dec. 1. MPEA management guarantees there will be no layoffs during the time of the extension, and there also will be complete retroactivity of any wage or benefit increases negotiated in the new contract.

The MPEA traffic and receiving contracts expire on Oct. 31 and Dec. 31, respectively.
