A Federal Parent PLUS Loan is a federally backed loan available to parents of dependent undergraduate students. The parent borrower is responsible for repaying the loan. Repayment begins within 60 days after the loan is fully disbursed. Interest begins to accrue after the first disbursement. Please note that loans cannot exceed a student's Cost of Attendance. You may contact Direct Loan Servicing for deferment options ([www.studentloans.gov](http://www.studentloans.gov)).

Academic year PLUS loans are disbursed to your student's account in two equal installments, usually at the beginning of the semester. Borrowers are subject to a credit check to determine credit-worthiness. If your loan is denied due to adverse credit, your student may pursue additional Unsubsidized Stafford funding. Your student must contact our office to request the additional funding.

You will be required to sign a Master Promissory Note with the Direct Loan Program (which is administered by the Department of Education). This is available online at [www.studentloans.gov](http://www.studentloans.gov). All parent proceeds are applied to outstanding current balances the student owes to LDS Business College. The remaining funds will be sent to the parent borrower, or if the borrower authorizes, to the student. The student must be enrolled for at least 6 credit hours each semester the loan is being requested. The student must also complete the 2014-2015 Free Application for Federal Student Aid (FAFSA) before a PLUS application will be considered.
