### NCVO - Review into the financial sustainability of the voluntary sector 2014

The National Council for Voluntary Organisations (NCVO) has launched a call for evidence to all voluntary organisations in England, providing them with an opportunity to share their experiences of what impact the recession has had upon them and how they have adapted to the changing funding environment.

The review aims to assess the financial sustainability of voluntary organisations, identify trends that have emerged in the income, expenditure and assets of the voluntary sector since the recession and provide analysis to enable the voluntary sector to plan for the future.

It will also make recommendations to policymakers on how to improve the financial sustainability of the voluntary sector and provide practical advice and support to help voluntary organisations become more financially sustainable. The review is due to publish a final report in early 2015.

### Fulfilling Lives: Ageing Better - Thanet Success

Social Enterprise Kent has been awarded  $\pounds 2,987,300$  by the Big Lottery Fund to lead a partnership of voluntary, statutory and private sector organisations to help 7,500 older people in Thanet. Thanet was one of just 15 to receive funding.

The project will run for five years to help reduce social isolation for older people in Thanet, and will run a range of activities to improve physical and mental wellbeing. These will be held in the heart of neighbourhoods, with a wide range of activities reflecting interests that are not just for 'old people'.

Support will be put in place for people who are facing key life changes that can be trigger points or isolation and depression - retirement, redundancy, major operations or disease, mobility issues, becoming a carer and bereavement.

## LandAid - Capital Grants for Building Projects

LandAid is a charitable foundation supported by the property industry, offering grants of between  $\pounds$ 75,000 and  $\pounds$ 150,000 and free professional property advice to registered charities in the UK.

## Kent County Council - Combined Members Grants

In 2014/15, each Kent County Council Member has £25,000 to allocate for community grants and/ or highway projects. Community Grants are available to properly-constituted organisations for projects that benefit local communities. All projects must contribute to KCC's priorities and represent value for money. The grant is a one-off award. There is no funding for any future costs.

Who can apply? Voluntary and community groups; societies and charities; social enterprises; parish/town councils, public sector services etc. Applications from faith groups will be considered, but must demonstrate how the project will bring wider community benefit.

Check with your local Member or Community Engagement Officer if you are unsure if your group or organisation is eligible and to find out how to apply.

**Deadline:** Applications can be made until March 2015 or until the funding is spent.
