

Substitute W-8 Tax Certification Form

This form is a substitute to the Internal Revenue Service W-8 Tax Form.

This form allows Exempt Foreign Persons to state that they are a foreign entity or exempt foreign person not subject to certain U.S. information return reporting or backup withholding rules. The American Internal Revenue Service requires Oddcast to withhold 30% of all international payments unless the individual or organization can document that it is exempt from US tax withholding. Therefore, unless you fill out the attached, all affiliate payments to you will be made after 30% is withheld.

An Exempt Foreign Person is (i) a nonresident alien individual or a foreign corporation, partnership, estate, or trust; (ii) who has not been, and plans not to be, present in the United States for a total of 183 days or more during the calendar year, and (iii) is neither engaged, nor plan to be engaged during the year, in a U.S. trade or business that has effectively connected gains from transactions with a broker or barter exchange.
