STATE TUITION DIFFERENTIAL GRANT (P E P C GRANT)

AVAILABLE For 2012-2013

The Florida State Board of Education has awarded the Nova Southeastern University Master's Program in Speech-Language Pathology funds for graduates enrolled in that program. These funds are designated for graduate tuition to offset the difference between state tuition and NSU's private tuition. These funds are for Master's level courses only (Pre-requisite credits are not considered). These awards are for degree seeking students and do not require repayment or service.

Eligibility: Florida Residents Graduate students.
Financial Aid eligibility is based on FAFSA. You must have filed for Financial Aid for the year 2012 - 2013. Failure to file for Financial Aid will disqualify you from eligibility. Check with the Financial Aid office prior to applying.

Priority Consideration:

- **Financial Need based on FAFSA**
- **Scholarship - 3.0 GPA or better at the graduate level prior to applying. If you are a first semester graduate student you must have an undergraduate GPA of 3.0 or better.**
- **Students from underserved groups and geographically remote areas**

Conditions: Awarded students must maintain a GPA of 3.0 and remain in good standing as a graduate student in this program. The award will be revoked if you are placed on probation for the term for which you are applying. Should your GPA fall below 3.0 or you are placed on professional probation, you will not be eligible for continued support. Dropping a course funded under this grant will jeopardize continued funding

How to Apply: Complete attached application form for "State Grant" and attach to it a brief statement describing the nature of your financial need and any changes in your financial status that was not reflected in your FAFSA.

Date of Awards: Awards are granted per Fall and Winter semesters. The results will be given in writing, by a memo from Dr. Shelley Victor that will be e-mailed to the awardee's NSU account. ***Please note: To make the deadline you may e-mail or fax in your application to kavel@nova.edu , (954) 262-2847 before Midnight on November 12th, 2012.**

Amount of Awards: Funds granted to students will be applied toward tuition for the semester indicated on the form. Amounts vary per semester. Awards are competitive due to a limited pool of funds.
