**Restrictions and Requirements:**

- 1) Submit one application per species. Applicant may not apply for or obtain more than one pre-authorized certificate of registration for each available species in a calendar year.
- 2) Submit first, second, and third choice counties.
- 3) Pre-authorized certificates of registration shall be held to all conditions established in R657-53-8, the Amphibian & Reptile Collection, Importation, Possession, Transportation, and Propagation Rule.

- 4) Applications will be accepted during the week of **January 14, 2013 – January 17, 2013. Applications must be received by the Utah Division of Wildlife Resources, Salt Lake Office by 6 p.m. Thursday January 17, 2012.** Applications received before or after this time period will not be accepted.
- 5) If necessary a drawing will be held for those species that have more applications than available pre-authorized certificates of registration on Tuesday, January 22, 2013.
- 6) Remaining pre-authorized certificates of registration will be available after the second full week of January on a first-come, first-served basis.
- 7) If available, pre-authorized certificates of registration shall be issued within five business days beginning the Monday after the second full week in January.
- 8) Pre-authorized certificates of registration are not transferable, nor may they be amended to change collection area, species, bag limits, or dates.

**APPLICATION MUST BE SIGNED:** All statements on this form are true and correct. I understand that if I subscribe to any false statement on this application, I am subject to criminal prosecution. I certify that I am eligible for the permit for which I have applied. I declare under penalty of perjury that I am qualified under all prevailing laws and statutes to purchase or possess this permit.
