Change is Coming – MDS 3.0 Training

If you haven't heard, MDS 3.0 is scheduled for implementation October 1, 2010 which will change the data collection process. This interactive session will discuss the major changes in the MDS, focus on the "hot spots" that will impact quality and reimbursement and give you tools to teach staff how to code properly. The session will look at the impact of the MDS 3.0 on the other processes including the RUGs system, Care Planning and Quality Measure/Quality outcomes.
